

U.S. Census Bureau Estimates for Race and Hispanic Origin, Vintage 2018

Each year, the Census Bureau produces population estimates at varying levels of geography. The age, sex, race and Hispanic origin estimates at the nation, state, and county level completes the 2018 vintage estimate package. Prior pieces of this release include national, state, county, metropolitan/micropolitan, and incorporated place (cities and towns) estimates for the 2018 vintage. All releases include annual estimates from Census 2010 to July 1, 2018. This final estimates release is expansive, so there are two fact sheets detailing the results: one for Race and Hispanic origin, and one for age and sex.

This fact sheet details Race and Hispanic origin at the state and county level. The five race categories used by the Census Bureau (White, Black or African American, American Indian or Alaska Native, Asian, and Native Hawaiian or Other Pacific Islander) were defined by the Office of Management and Budget (OMB) in 1997. Any determination of race is through self-identification, and a person who identifies with multiple race groups is included in the "Two or More" category.

The term minority in this document refers to those who identified as Hispanic or any race category other than white. When discussing racial groups, this document is referring to people who identify as non-Hispanic, single-race (i.e. White, Asian, Native Hawaiian and Pacific Islander), or Two or More Races.

National Picture

These estimates highlight increasing diversity across the United States. All race and ethnic groups grew between the 2010 and 2018 estimates, but non-Hispanic Whites were the slowest growing, with only .1 percent growth. Regionally, non-Hispanic Whites have declined in the Northeast and Midwest, but continue to slowly grow in the South and West.

Components of population change are available at the national level. Between 2010 and 2018, Asians were the fastest growing racial group due to net migration, the Hispanic population grew mostly due to natural increase, and the non-Hispanic White population continues to experiences natural decrease (more deaths than births).

Race and Hispanic Origin in Utah

Utah is becoming increasingly diverse. In 2010, Utah was 19.4 percent minority, and is now 22 percent minority. Since 2017, Utah's minority population has increased 3.8 percentage points from 669,578 to 695,080.

The Asian, Two or More Races, and Black populations (in that order) experienced the fastest growth between 2017 and 2018, while Whites experienced the slowest growth between 2017 and 2018.




The Hispanic or Latino population, Utah's largest minority group, increased 3.3 percent, from 435,928 in 2017 to 450,218 in 2018. Utah's Asian population is the second largest minority group in Utah (75,471 individuals). It maintains its pattern as the fastest growing racial minority in Utah, growing 6.3 percent since 2017, and 48.5 percent since 2010, followed closely by the Two or More Races population at 42.5 percent since 2010.

Utah's minority population may only account for 22 percent of the total population, but over forty percent (41.1) of statewide growth between 2017 and 2018 came from the minority population. The Hispanic or Latino population accounted for over half of this growth (56 percent), and the Asian population and Two or More Races group collectively added 31 percent of minority growth.

Age of Minorities in Utah

Utah is a young state due to high fertility and a strong economy that attracts working age individuals, but these age patterns differ by race/ethnicity. The non-Hispanic White population has the highest percentage of the 65+ population, the second highest percentage of the 18+ population (behind the Asian population), and the second lowest percentage of the under 18 population. The low percentage of under 18 year olds is mostly due to falling fertility rates for the non-Hispanic White population, and is consistent with national trends.

Over one-third (35.5 percent) of the minority population is under age 18, and one in four Utahns under age 18 are minorities. Two thirds of these minority children are Hispanic. Additionally, half of Two or More Races, the second fastest growing racial minority in the state, is under the age of 18 and only 2.7 percent are 65 years and over. One in ten of the 65 and older population are minorities.

Race and Hispanic Origin in Utah Counties

San Juan County continues to be the only county in the state which is minority majority, with 56.4 percent of the population identifying as a minority, and 84 percent of their minority population (7,244 individuals) identifying as American Indians (the largest share in the state). Salt Lake County has the largest minority population at 324,783 or 29.3 percent of the population, with the Hispanic population comprising two thirds of the minority population, and a higher than average share of Asians (4.5 percent).

Morgan County has the largest county percentage of non-Hispanic Whites (94.6 percent), or is the least racially diverse of Utah's counties. Salt Lake County has the largest percentage of Black or African Americans, Asians, and Native Hawaiian or Pacific Islanders, while Utah County has the largest percentage of Two or More Races, and Weber County has the largest percentage of Hispanic or Latinos.
