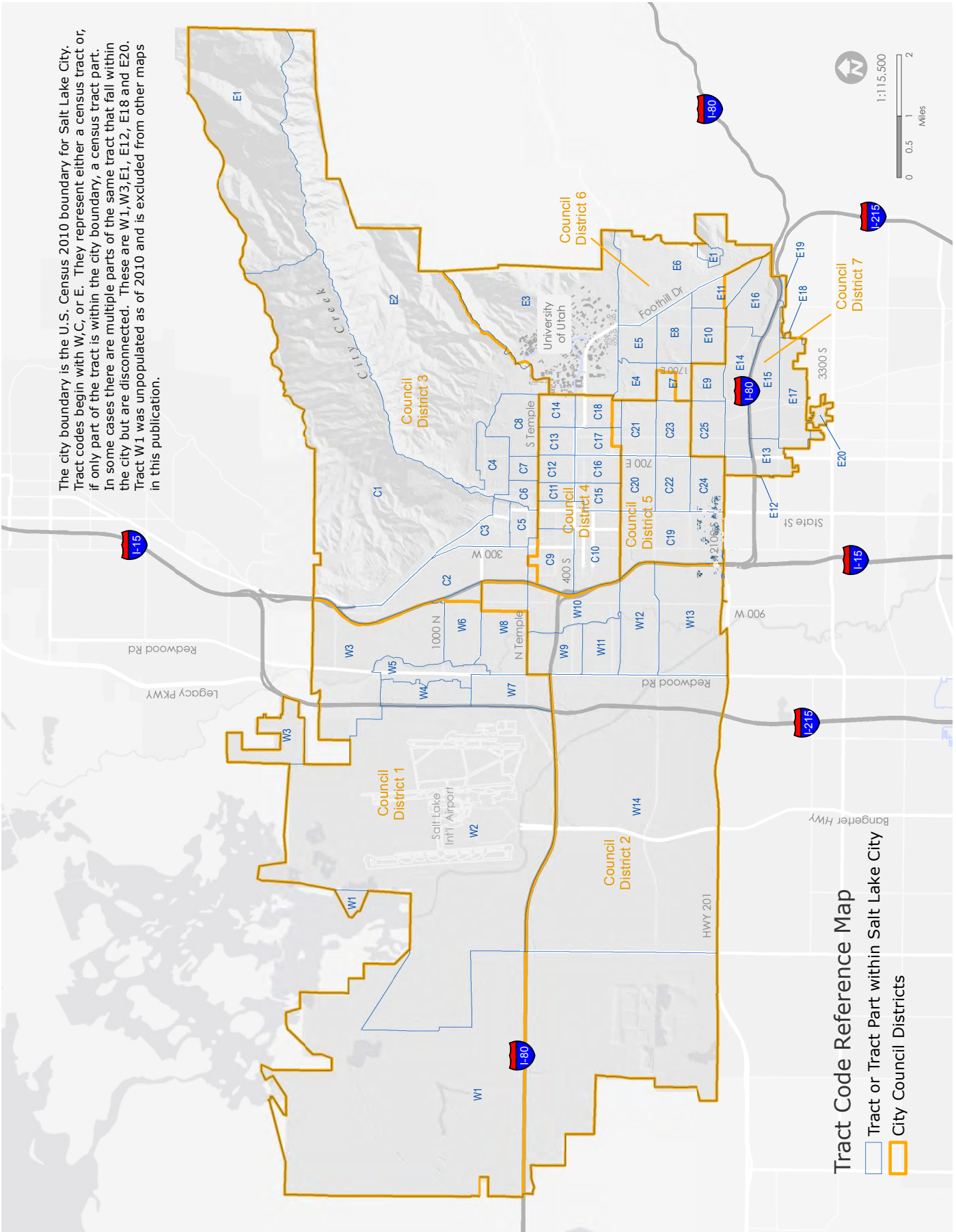
Figure 29	Foreign-Born Population in Salt Lake City, 2008–2012	70

The city boundary is the U.S. Census 2010 boundary for Salt Lake City. Tract codes begin with W,C, or E. They represent either a census tract or, if only part of the tract is within the city boundary, a census tract part. In some cases there are multiple parts of the same tract that fall within the city but are disconnected. These are W1,W3,E1, E12, E18 and E20. Tract W1 was unpopulated as of 2010 and is excluded from other maps in this publication.

INTRODUCTION

This publication has been prepared for the Housing and Neighborhood Development Division (HAND) of Community and Economic Development, Salt Lake City Corporation. The contents have been designed and customized to meet the requirements specified by HAND. The geographic focus of this work is Salt Lake City, City Council Districts, and Census Tracts.

The document is organized thematically into three major sections: housing, population, and change products. The housing section includes information on homeownership rates by race and ethnicity, households by selected types, and housing affordability. The population section presents information on selected age metrics, group quarters populations, socioeconomics, and the homeless. The change products evaluated the changes from 2000 to 2010 for population and household metrics.

The analyses based on 2010 Census data include only the census tracts that are fully and partially contained within Salt Lake City. Twelve of 59 Salt Lake City census tracts are partial tracts. Data for these partial tracts appear in the data tables and maps. Some of these partial tracts have either no population or minimal population and are therefore excluded from the discussion in the text.¹ The rest of the partial tracts do have sufficient population counts to merit inclusion in the textual discussion.² The housing affordability analysis, which is based on Salt Lake County Assessor data, is presented in the same way. The socioeconomics section is based on the American Community Survey which generates small area data for entire Census Tracts, so data from tracts that cross the Salt Lake City boundary are included. The change products are also produced at the tract level and are reported in the same way. The reader should consult the notes that appear with the tables for details on the geography that applies to each set of data.

HOUSING

2.1 Homeownership Rates

The following set of maps (Figures 1 through 8) and tabular data (Tables 1 through 16) show the total number of occupied housing units and the number and share of these that are owner rather than rental units. Housing units are classified according to occupancy status (occupied or vacant) and tenancy (rented or owned). The occupancy rate is the complement of the vacancy rate, meaning that the sum of the two is 100 percent. For occupied units, the rental and ownership rates also sum to 100 percent. These data are presented for the census tracts and city council districts within Salt Lake City. The data in this section was collected in the April 1, 2010 enumeration of resident population and housing units conducted by the U.S. Bureau of the Census. There were a total of 80,724 housing units enumerated in Salt Lake City. Of these, 74,513 were occupied and 6,211 were vacant. Of the occupied units, rental units were 38,440 and the balance of these (36,073) was owner-occupied.

The first set of tables and maps shows the homeownership rates of the total occupied housing units in Salt Lake City. Additional detail is presented for the race and ethnicity of the householder. Note that only occupied housing units are shown in these tables and maps. By definition, each occupied housing unit contains a person or persons referred to as a household. Householders are self-identified and are generally understood to be the person in whose name the property is either owned or rented. Race categories include White, Black or African American, American Indian or Alaska Native, Asian, Native Hawaiian or Other Pacific Islander, and Some Other Race. People may select more than one race category. In this document, persons classifying themselves as either multiracial or Some Other Race are combined into a single category. Hispanic or Latino is the only ethnicity recognized in the federal statistical system, and it is a separate category from race. In this document, each race group is composed of persons who answered a single race category. Unless otherwise specified, in this document persons classified within any race group include both Hispanic and non-Hispanic.

The overall homeownership rate for Salt Lake City is 48.4 percent, with the balance of households (51.6 percent) living in rental units. Council District 6 has the highest homeownership rate (67.1 percent) followed by Council District 1 (64.2 percent). Council District 4 has the lowest ownership rate (21.6 percent) and therefore the highest rental rate (78.4 percent). The tracts with the highest (tract 1148 with 93.8 percent ownership rate) and lowest (tract 1014 with a 2.3 percent ownership rate) rates are contiguous to each other and in the University of Utah area. This excludes from consideration tracts that are not fully contained in Salt Lake City and that have minimal population.

Non-Hispanic White households have an overall homeownership rate of 52.8 percent. The homeownership rate is highest for Non-Hispanic Whites in Council District 1 at 76.1 percent, and lowest in Council District 4 at 24.5 percent. Black or African American households have a citywide ownership rate of 20.0 percent. Homeownership rates for Black or African American households are highest in District 1 at 37.3 percent and lowest in District 4 at 9.0 percent. American Indian and Alaska Native households have an ownership rate of 20.0 percent, with the highest rate in District 1 (38.9 percent) and lowest rate in District 3 (6.5 percent). Asian householders have a citywide homeownership rate of 36.1 percent. This rate is highest in District 1 at 70.6 percent and lowest in District 4 at 13.8 percent. Native Hawaiian and Other Pacific Islander householders residing in Salt Lake City have a homeownership rate of 42.4 percent. This is highest in Council District 2 (55.4 percent) and lowest in Council District 4 (8.3 percent). Homeownership rates for the combined multiracial and Some Other Race householders average 34.9 percent for Salt Lake City as a whole. This rate is highest in District 1 (48.2 percent) and lowest in District 4 (10.9 percent). Hispanic householders (who may be of any race) have an average homeownership rate of 37.3 percent. This rate is highest in District 1 (51.0 percent) and lowest in District 4 (12.2 percent).

Figure 1: Homeownership Rate of Total Householders in Salt Lake City, 2010

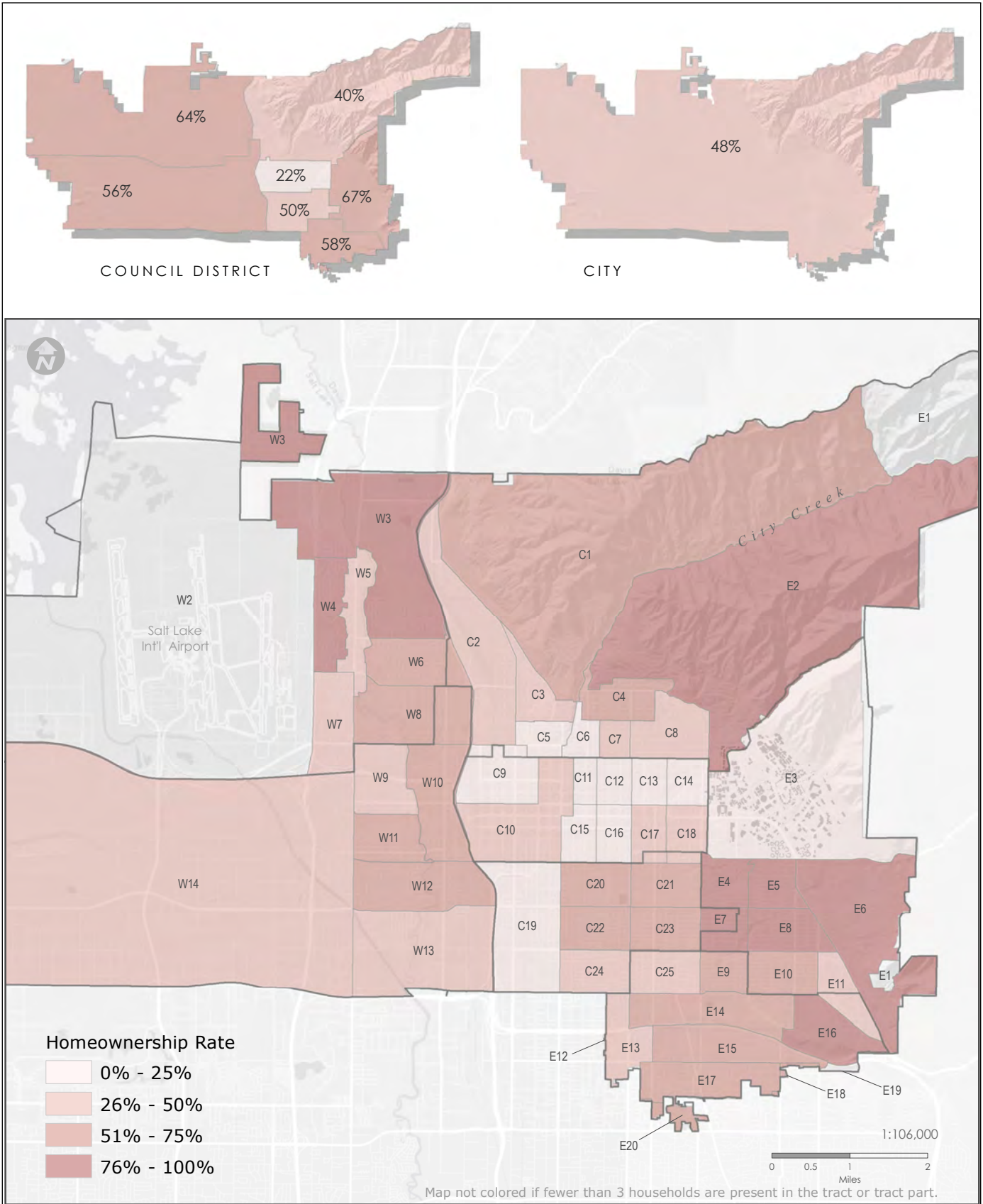

Figure 2: Homeownership Rate of Non-Hispanic White Householders in Salt Lake City, 2010

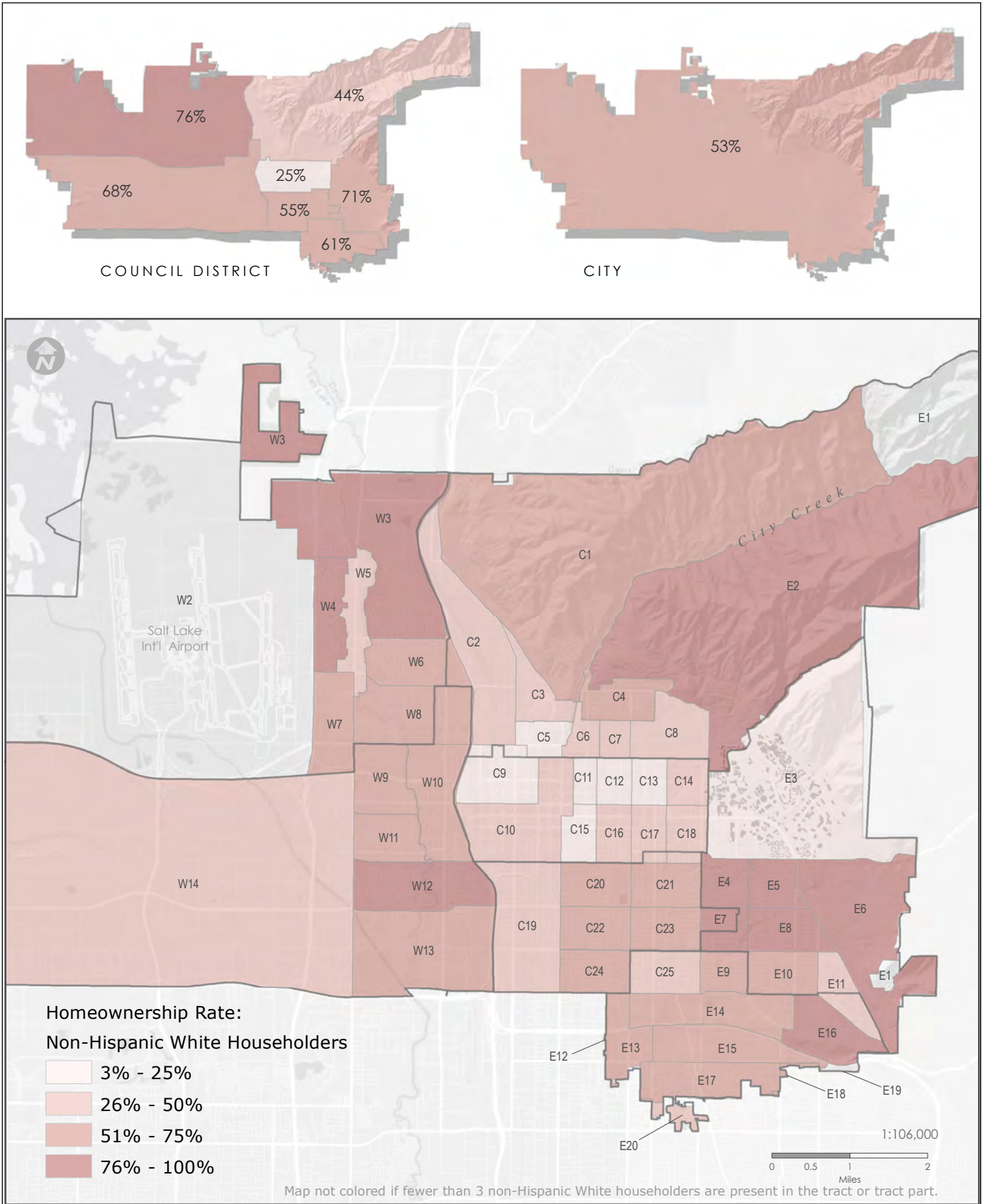

Figure 3: Homeownership Rate of Black Householders in Salt Lake City, 2010

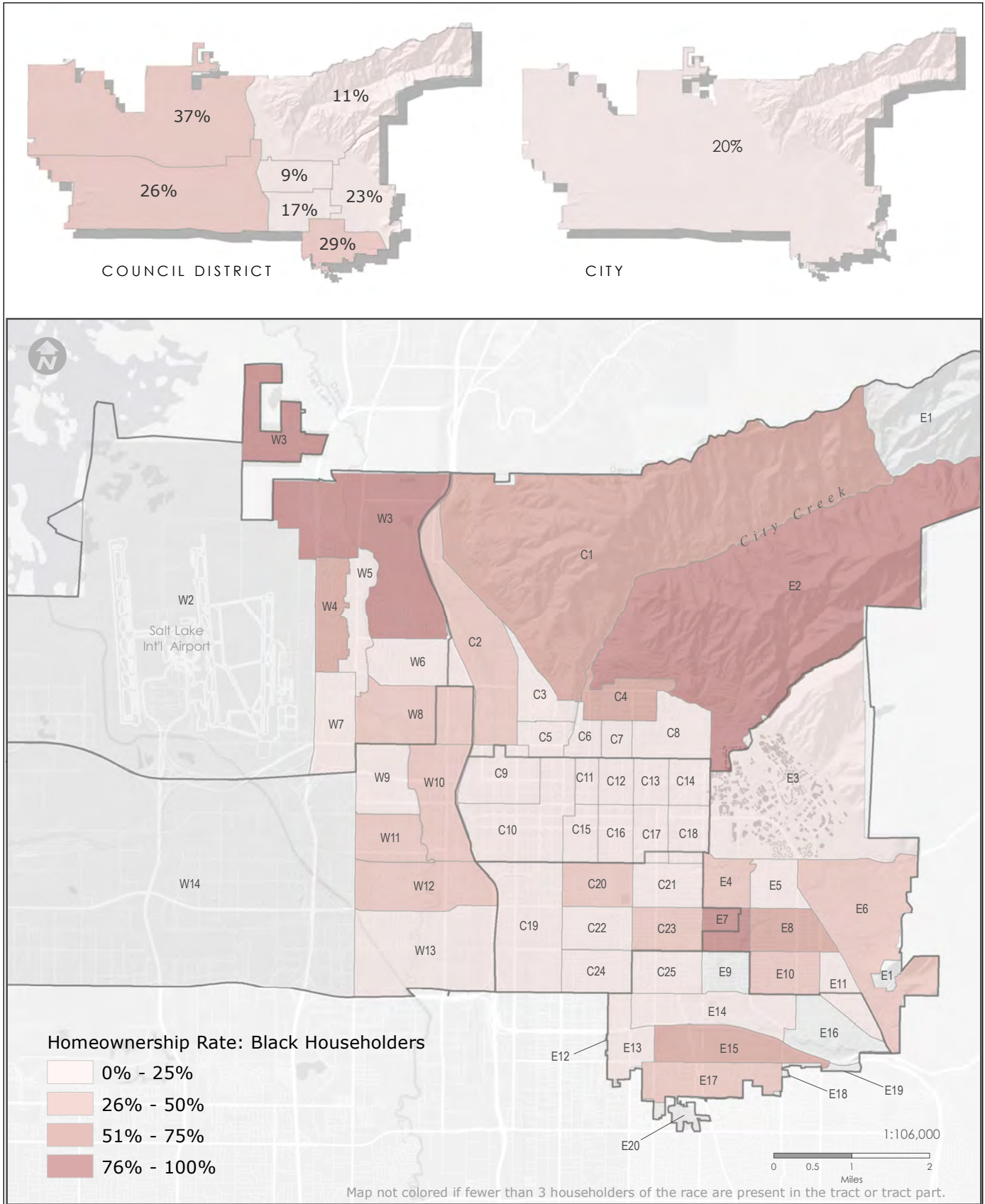

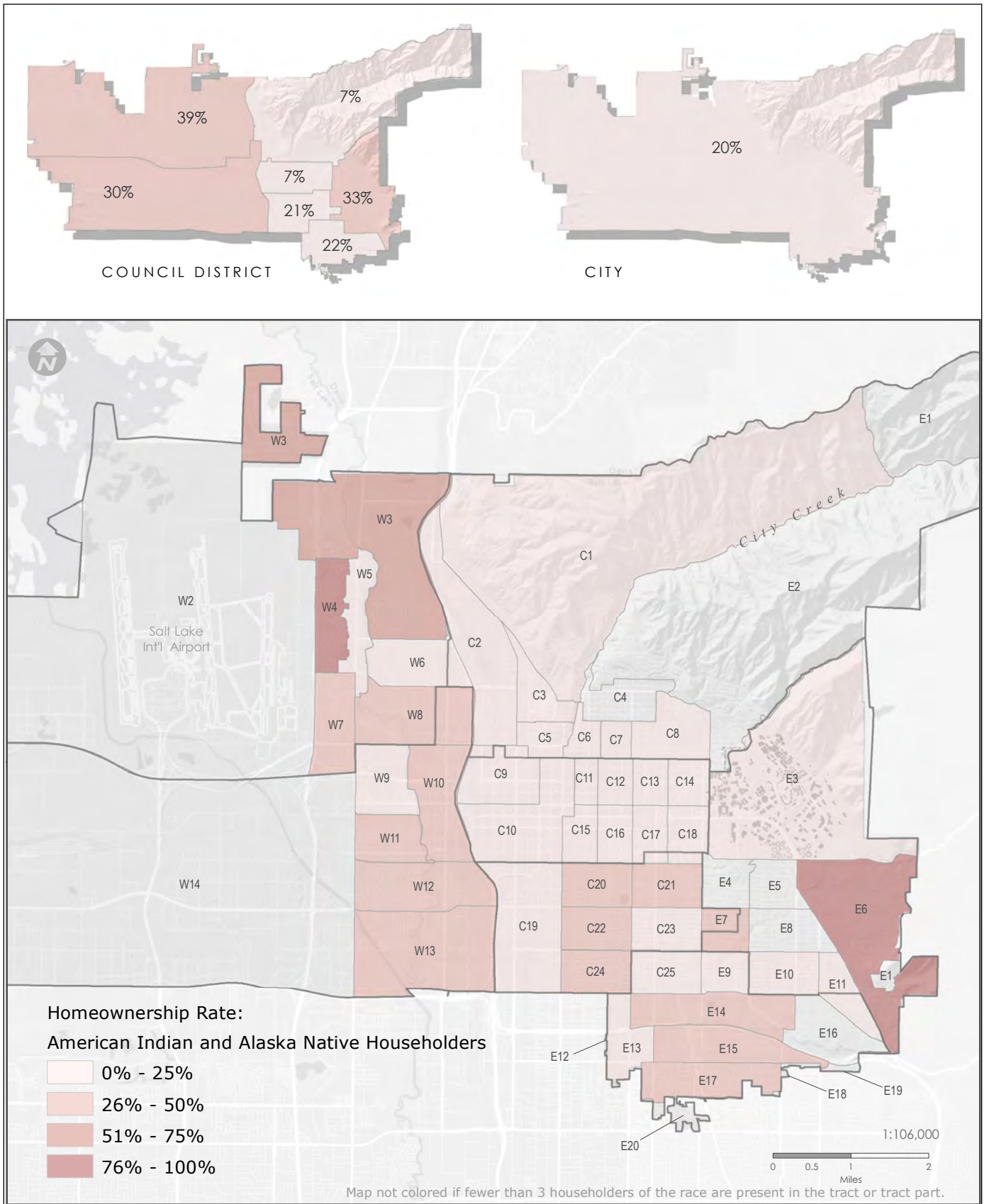

Figure 5: Homeownership Rate of Asian Householders in Salt Lake City, 2010

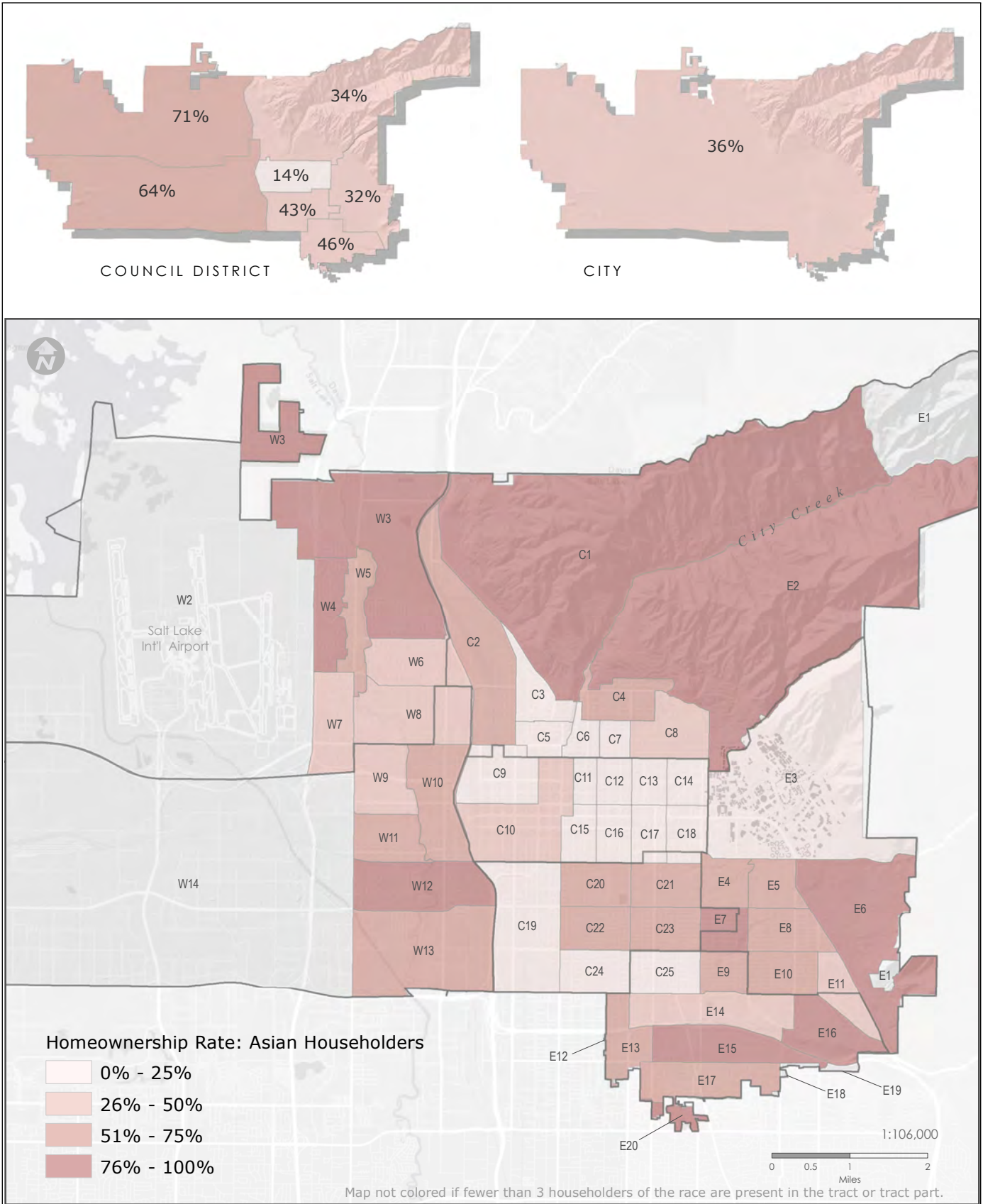

Figure 6: Homeownership Rate of Pacific Islander Householders in Salt Lake City, 2010

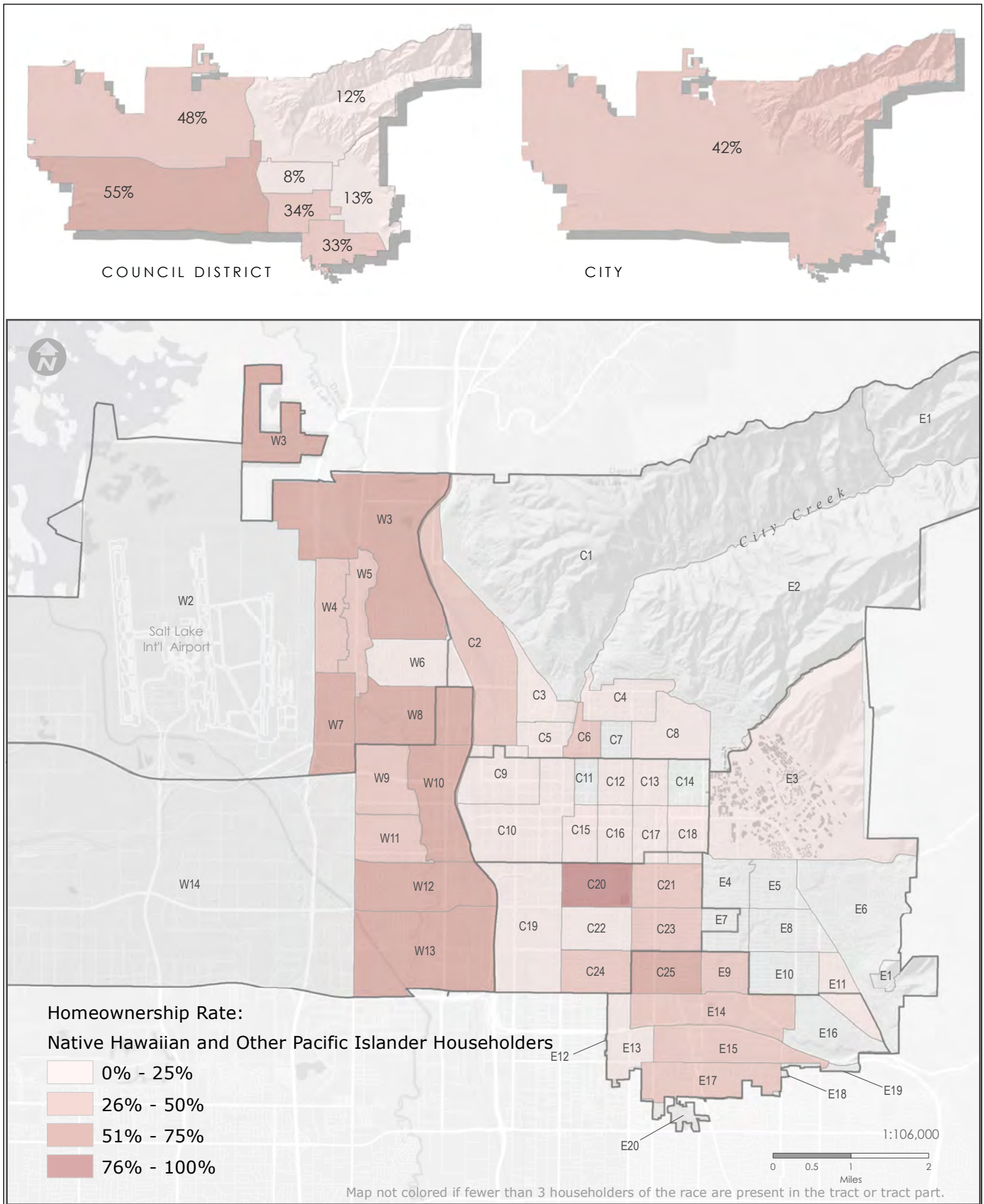

Figure 7: Homeownership Rate of Other or Multiple Race Householders in Salt Lake City, 2010

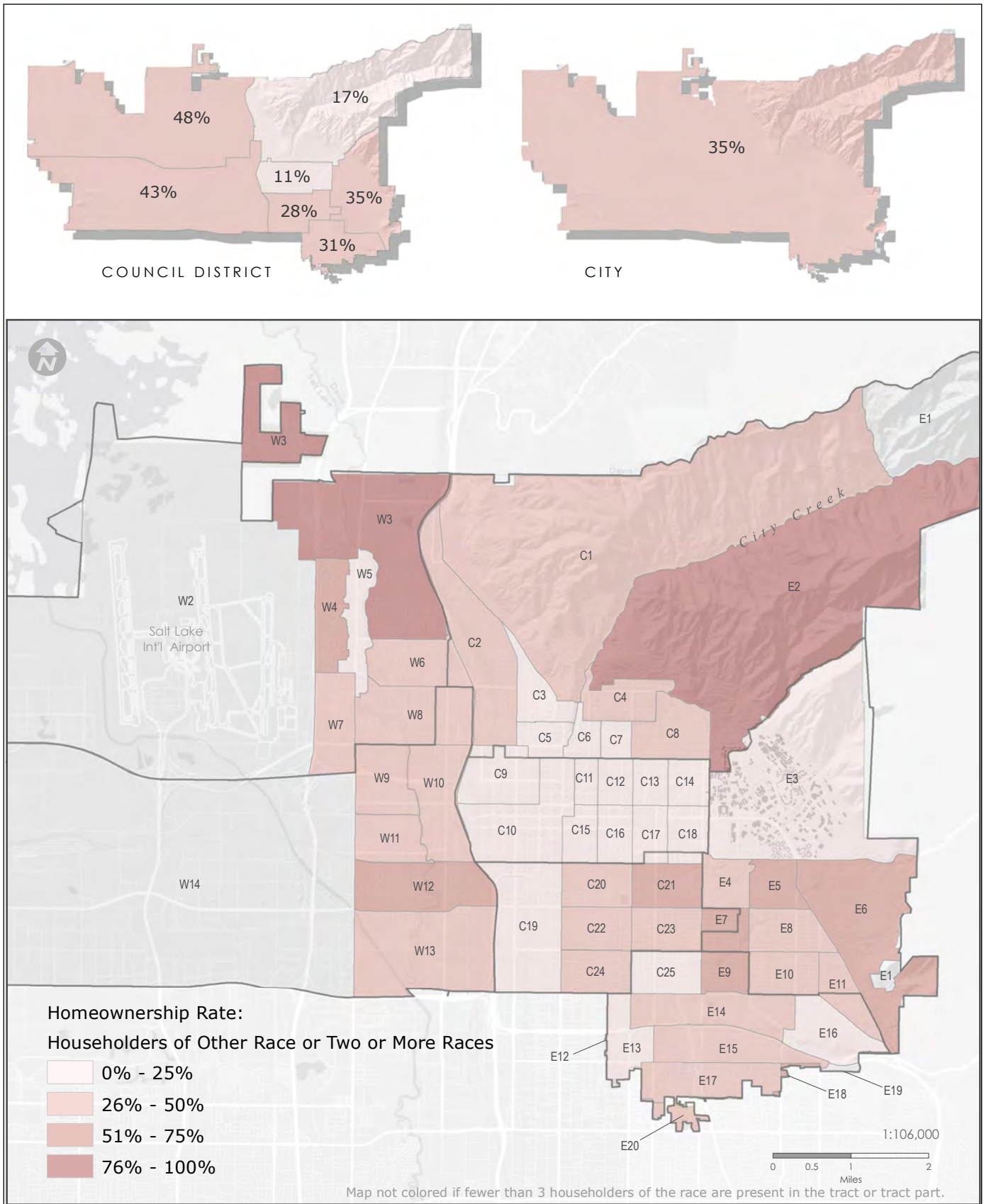

Figure 8: Homeownership Rate of Hispanic Householders in Salt Lake City, 2010

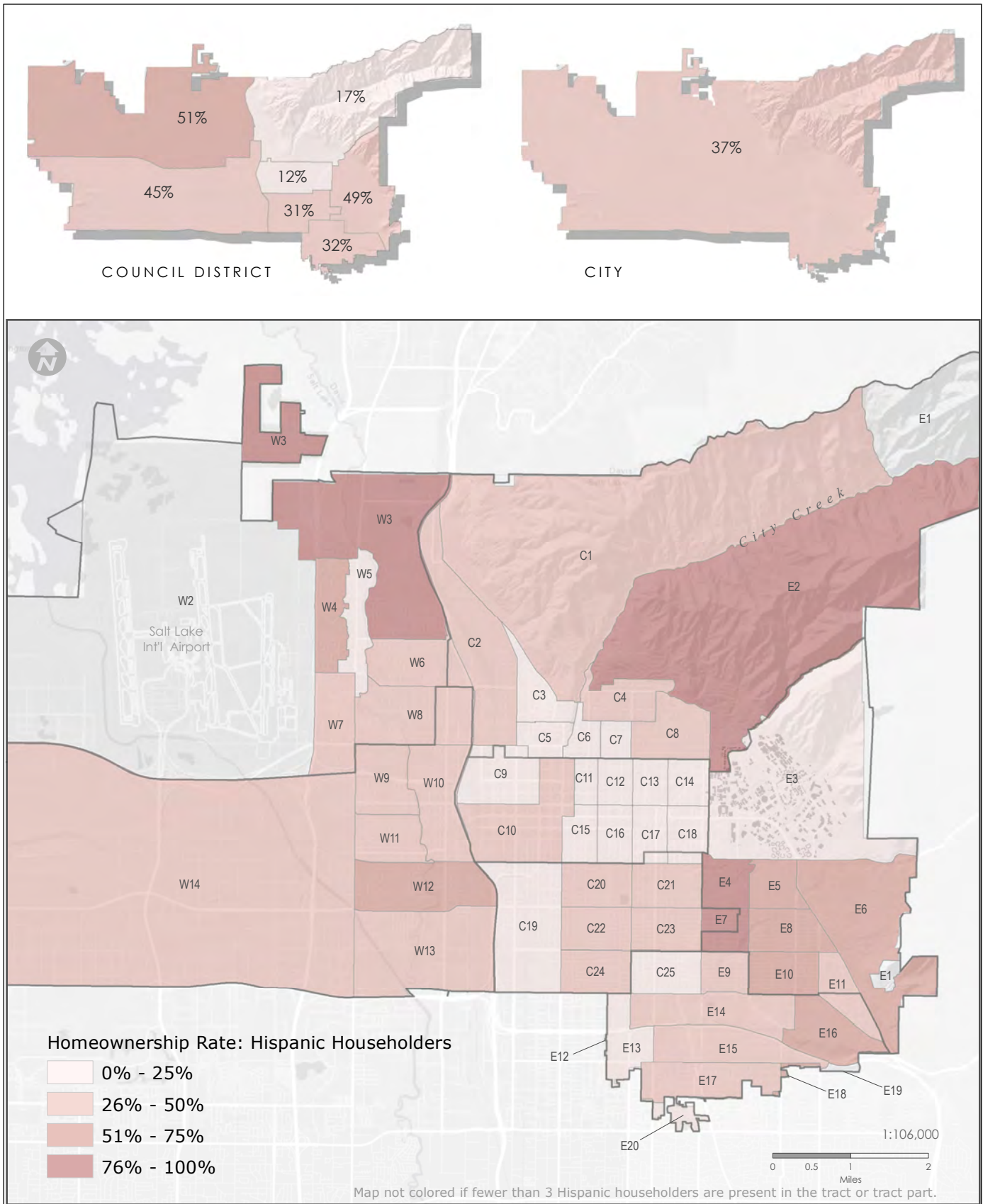

2.2 Households by Type

This section presents maps (Figures 9 through 19) and tabular data (Tables 17 through 38) for households of selected types. Households are composed of all the people who occupy a housing unit and are categorized according to the relationships between residents. These occupants can be one person living alone, one or more families living together, or any group of related or unrelated persons residing together. The householder is self-identified and is generally understood to be the person in whose name the property is either owned or rented. This is the person listed first on the response to the questionnaire. In this data set, the number of householders or households is equivalent to the count of occupied housing units. Households are classified as family or nonfamily. Family households are people living together related by birth, marriage, or adoption. Nonfamily households are single persons either living alone or with other unrelated individuals.

This section includes counts and shares of households with children as well as those with persons 65 years and older. Information on persons per household is also presented. Counts and shares of selected types of family households are included: total, those with children, those with husband and wife (both with and without children), those with single householders with children, and those with five or more family members. Counts and shares of nonfamily households as well as households with a single resident are also included. These data are presented for the census tracts and city council districts within Salt Lake City. The data for this section is from the 2010 Census. As in the other tract comparisons discussed in this document, only those containing a minimum threshold population are discussed.

Youth reside in 27.5 percent of all households in Salt Lake City. Nearly half of the households in District 1 (47.5 percent) and District 2 (48.3 percent) contain children, while only 11.2 percent of District 4 households have persons under the age of 18. Tract 1140 within District 4 has the lowest share of households with children (6.1 percent) and Tract 1003.07 within District 1 has the highest share (64.3 percent).

Salt Lake City has 13,382 households with at least one resident 65 years or older, which is 18.0 percent of all households. Council District 3 contains 18.1 percent of the city's households with at least one person 65 years or older. The share of total households with at least one person 65 years or older is greatest in Council District 6, with a 23.5 percent share, and least in Council District 5 with a 14.1 percent share. Census Tract 1014, which contains the University of Utah, has the smallest share at 1.4 percent. The part of Tract 1118.02 that is in Salt Lake City is on the southern edge of District 7 and contains 293 households, of which 40.6 percent (the highest share among tracts) have at least one resident 65 years or older.

In the 2010 census, Salt Lake City has a total household population of 181,645 residing in 74,513 households, resulting in an average of 2.44 persons per household. Among the council districts, District 4 has the greatest number of households (14,113) and the fewest persons per household (1.76). At the other extreme is District 2 with 7,703 households and an average household size of 3.50. The tract with the smallest household size is Census Tract 1021 in District 4 with 1.44 persons per household. Tract 1003.07 in District 1 has 4.28 persons per household, the highest among all Salt Lake City tracts.

Over half (52.5 percent) of Salt Lake City's households are families. This share is highest in District 1, where nearly three quarters (73.3 percent) of households contain families. At the other extreme, just over a quarter (27.4 percent) of District 4 households contain families. Tract 1003.07 located in District 1 has the highest share (88.5 percent), and Census Tract 1021 located in District 4 has the lowest share (18.3 percent) of family households.

One in four households in Salt Lake City are family households with children, and the geographic distribution of family households with children follows the same general pattern as family households. Districts 1 and 2 have the highest shares (41.2 and 41.1 percent, respectively). Only one in ten (10.3 percent) of the households in District 4 have children as residents. Tract 1003.07 within District 1 has the highest share of family households with children

(56.0 percent), and Census Tract 1140 within District 4 has the lowest share (5.2 percent).

Husband-wife family households are 37.9 percent of Salt Lake City's total households. Considering shares within districts, District 4 has the lowest share (18.5 percent) while District 6 has the highest (57.1 percent). Tract 1148 of District 3 has the highest share (73.1 percent) while Tract 1021 of District 4 has the lowest share (9.3 percent). Among the 28,240 husband-wife family households in Salt Lake City, just under half (12,981 or 46.0 percent) of these also have children under 18 years old. These husband-wife family households with children are 17.4 percent of total households in Salt Lake City. This share is greatest in District 1 (29.5 percent) and lowest in District 4 (6.1 percent). Tract 1003.07 in District 1 has the highest proportion (43.8 percent), and Tract 1021 in District 4 has the smallest share (2.0 percent) of husband-wife family households with children.

There are 6,480 households with a single householder and also a child under 18, which is 8.7 percent of total households in Salt Lake City. This share is lowest in District 4 (4.7 percent) and highest in District 2 (17.4 percent). Tract 1140 in District 4 has the smallest share (2.3 percent), and Tract 1027.02 in District 2 has the largest share (21.1 percent) of total households that have a single householder and at least one child under 18.

Salt Lake City has 7,730 households that are family households with at least five residents. This is one in ten (10.4 percent) of all households in the city. Over half (56.1 percent) of these are in the combined area of Districts 1 and 2. The family households with at least five members are 26.8 percent and 28.4 percent of total households in Districts 1 and 2, respectively. In contrast, only 2.5 percent of total households in District 4 are family households with at least five members. Tract 1003.07 (District 1) has the highest share (39.8 percent) and within Tract 1025 (District 4) has the lowest share (0.5 percent).

Nearly half (47.5 percent) of all households in Salt Lake City are nonfamily households. This share is greatest in District 4 (72.6 percent) and lowest in Districts 1 and 2, with 26.7 percent and 27.9 percent shares of nonfamily households. Tract 1003.07 in District 1 has the smallest share (11.5 percent), and Tract 1021 in District 4 has the largest percent (81.7 percent) of nonfamily households.

In the 2010 Census, there are 25,812 householders living alone, representing over a third (34.6 percent) of total households. About half (49.2 percent) of these are in the combined areas of Districts 3 and 4. Well over half (53.5 percent) of District 4 households are one-person households, while this ratio is one in five for Districts 1 (20.9 percent) and 2 (20.1 percent). Over two-thirds (68.7 percent) of the households in Tract 1021 in District 4 are one-person households. Less than one in ten (8.1 percent) of Tract 1003.07 households in District 1 are householders living alone.

Figure 9: Percent of Households with Children under 18 in Salt Lake City, 2010

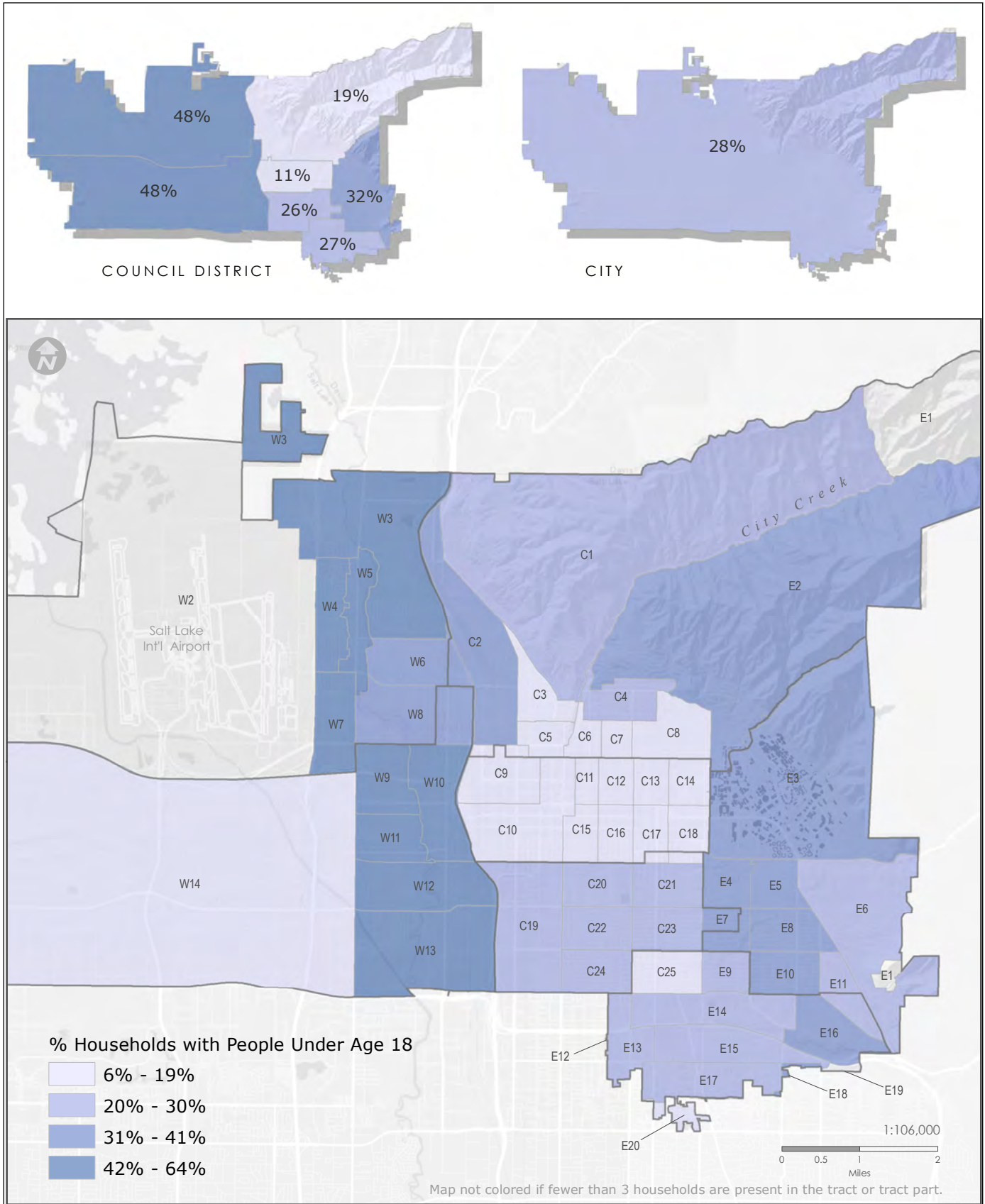

Figure 10: Percent of Households with People 65 and Over in Salt Lake City, 2010

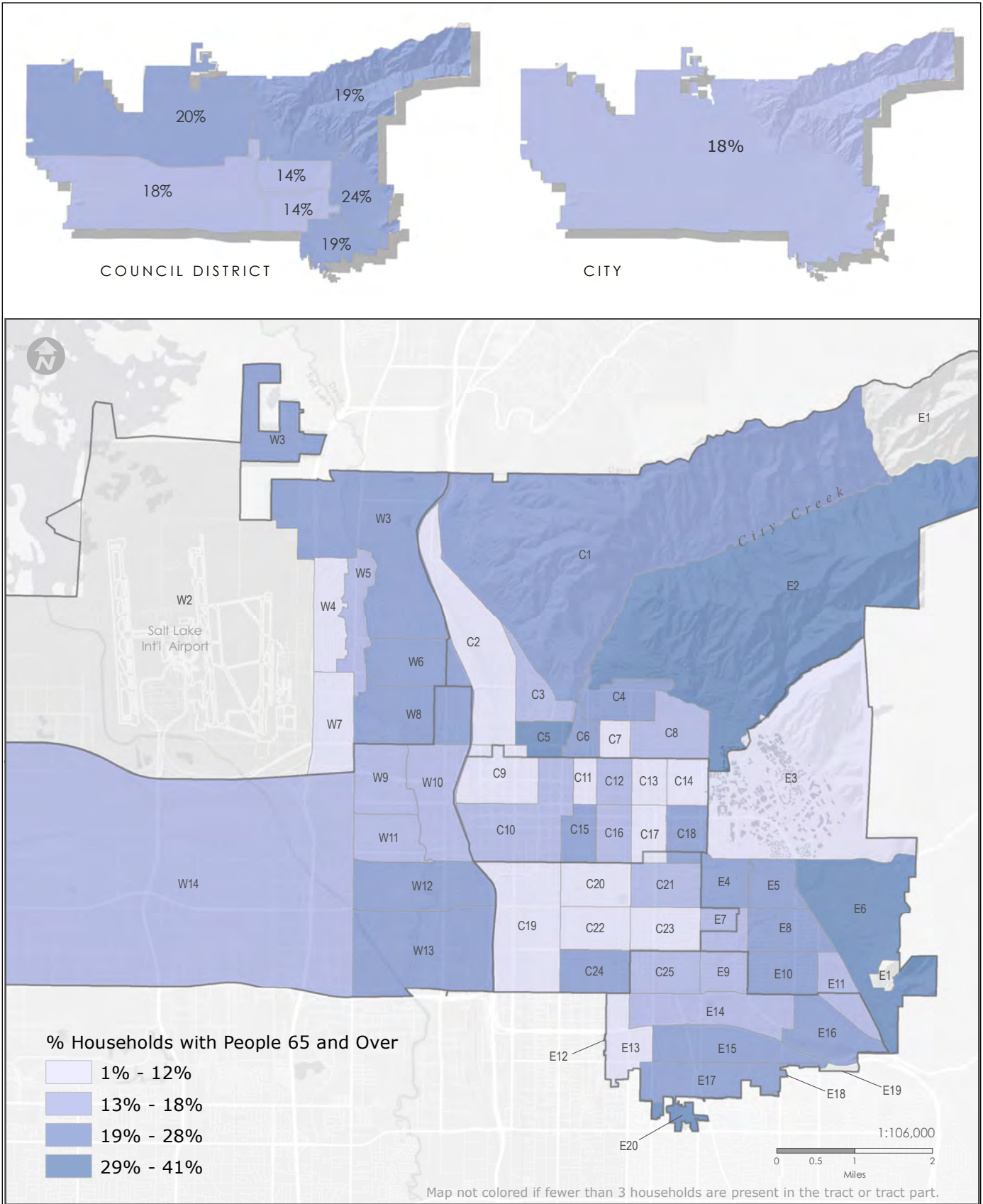

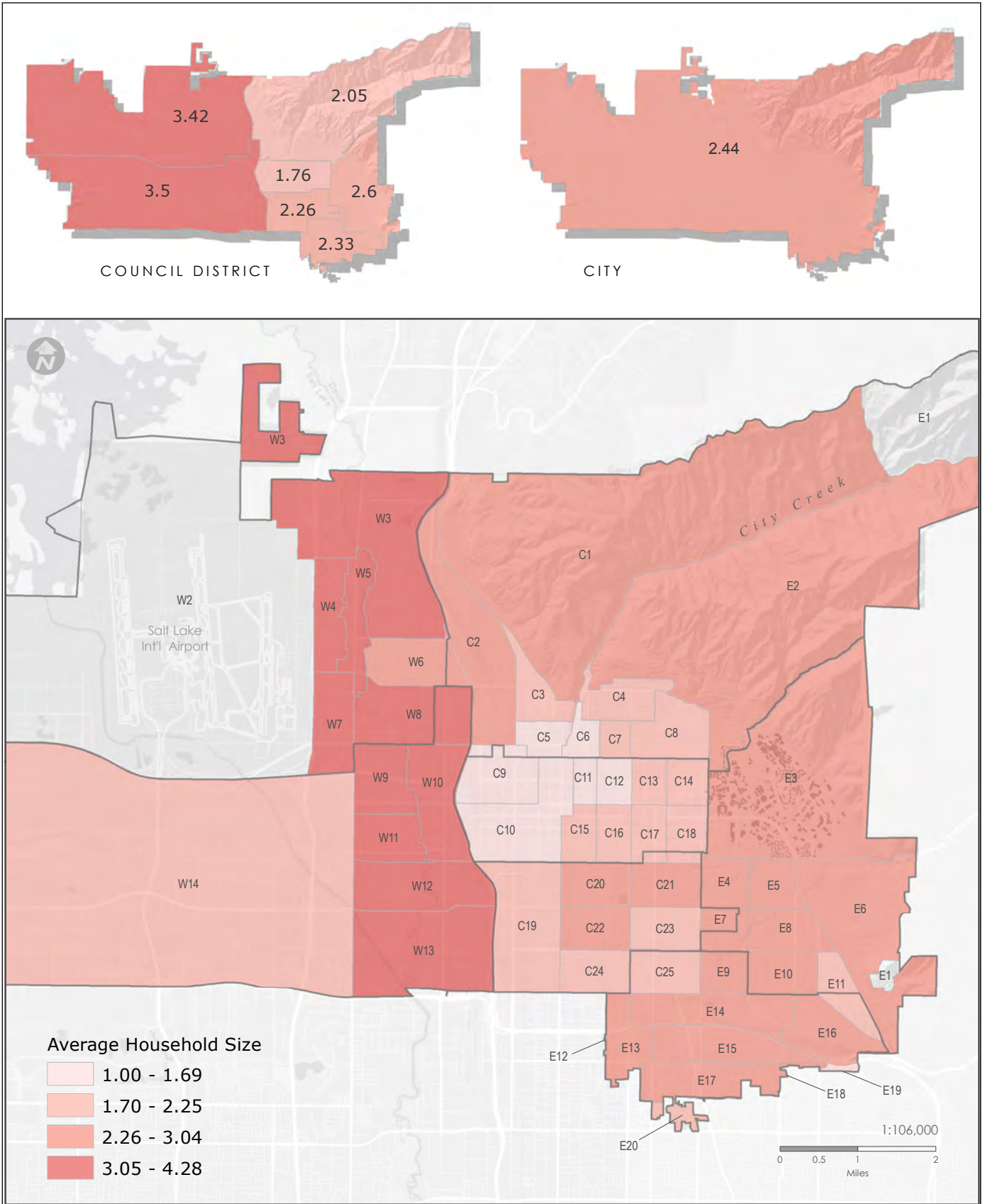

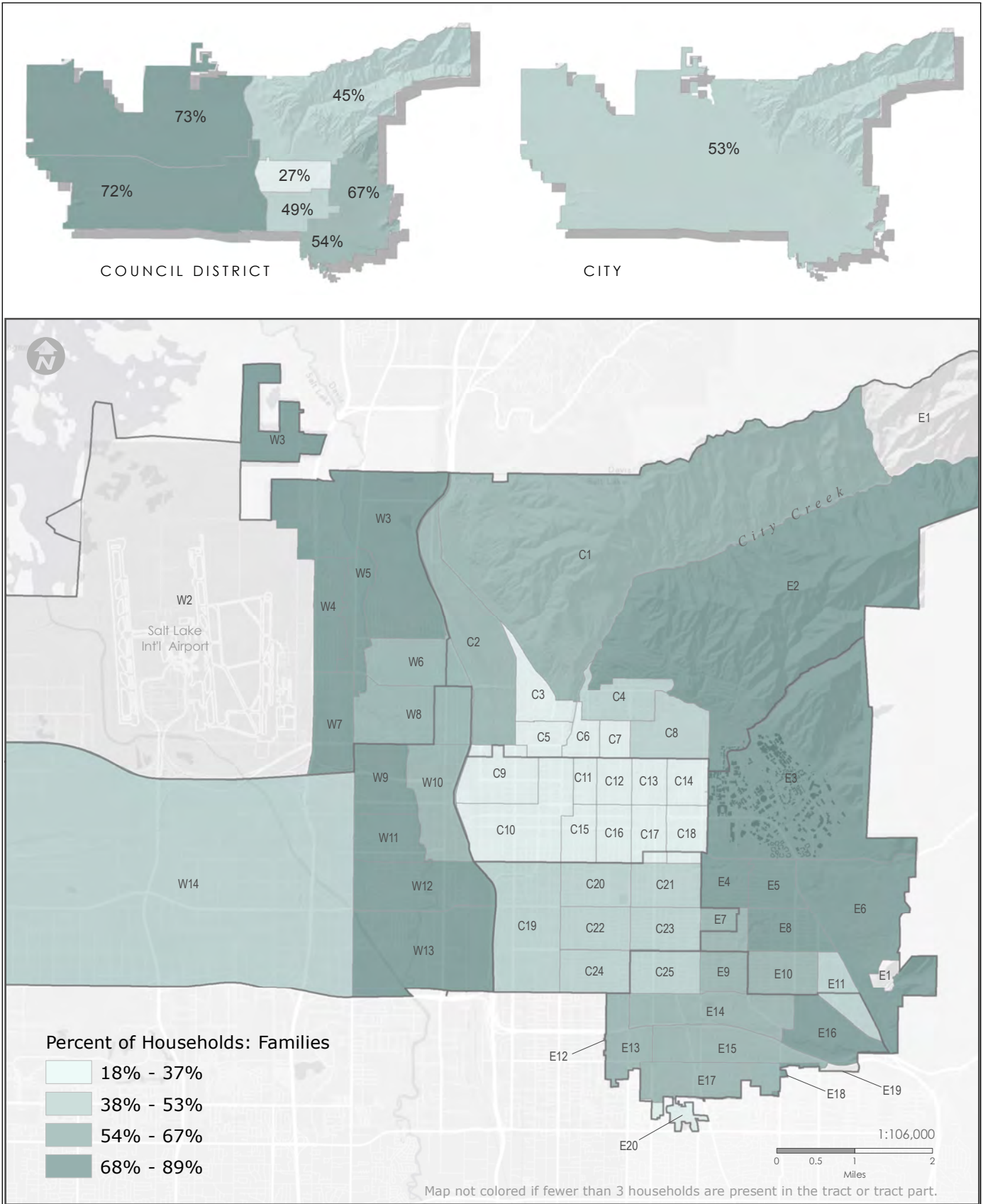

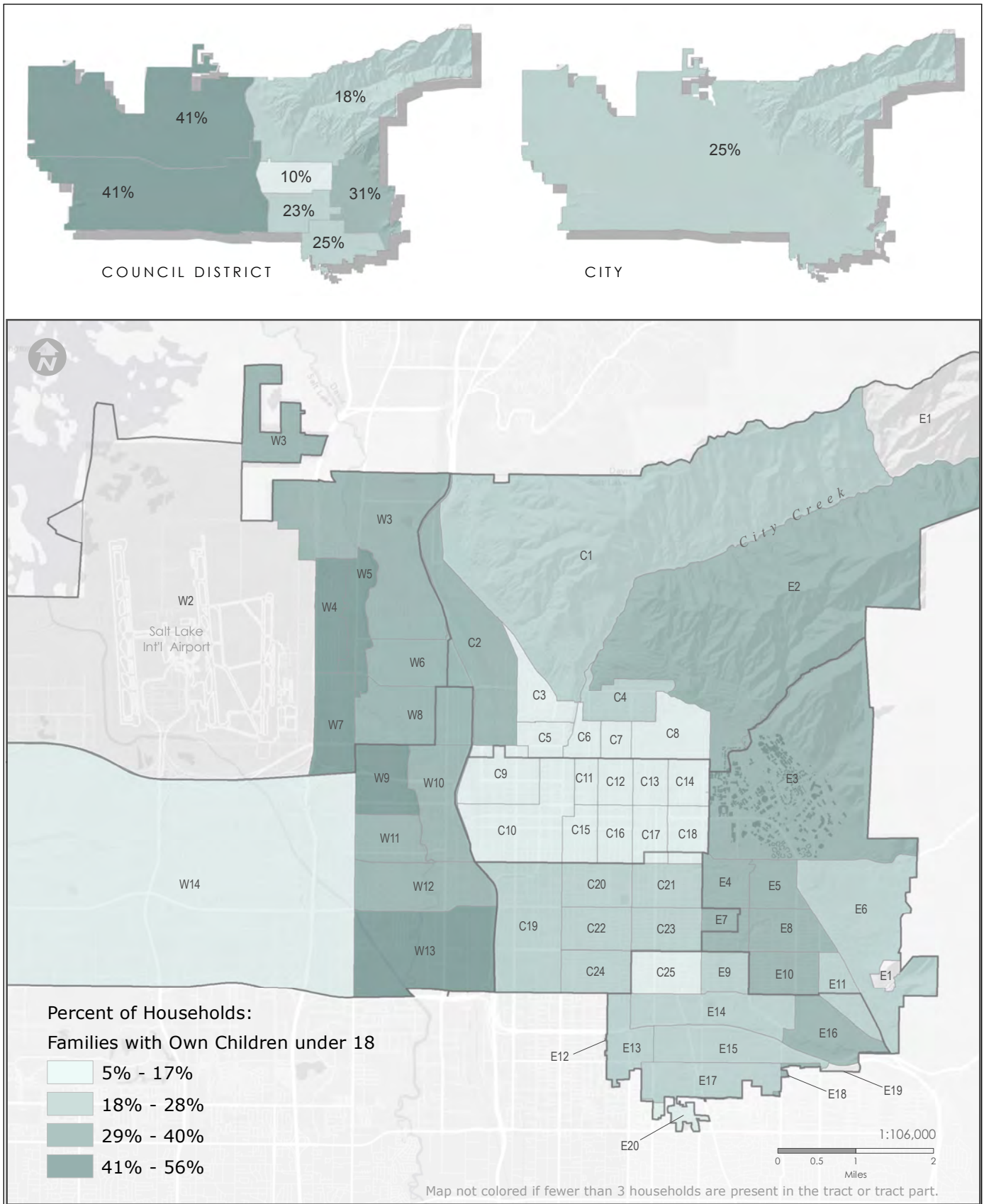

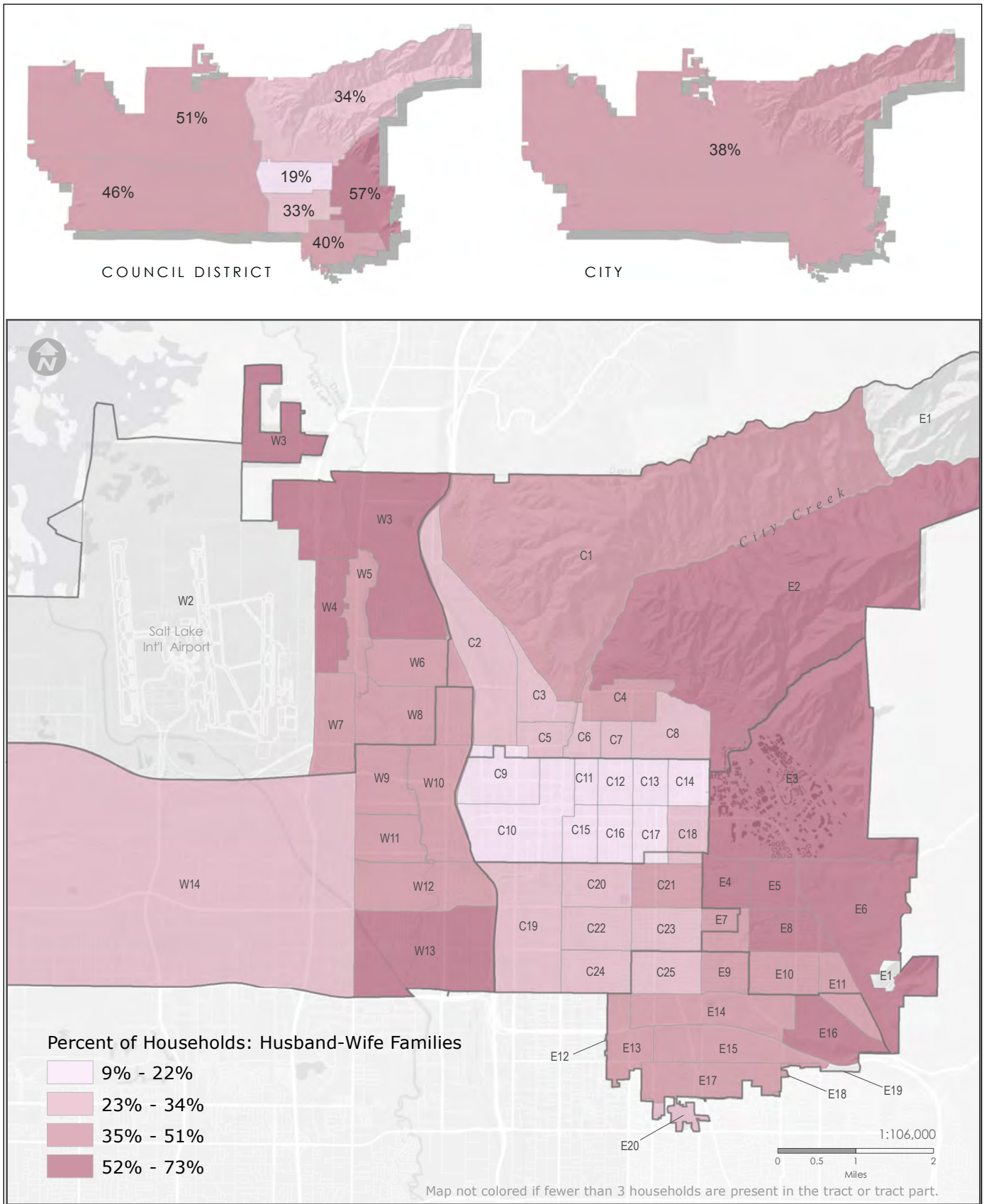

Figure 15: Husband-Wife Families with Own Children in Salt Lake City, 2010

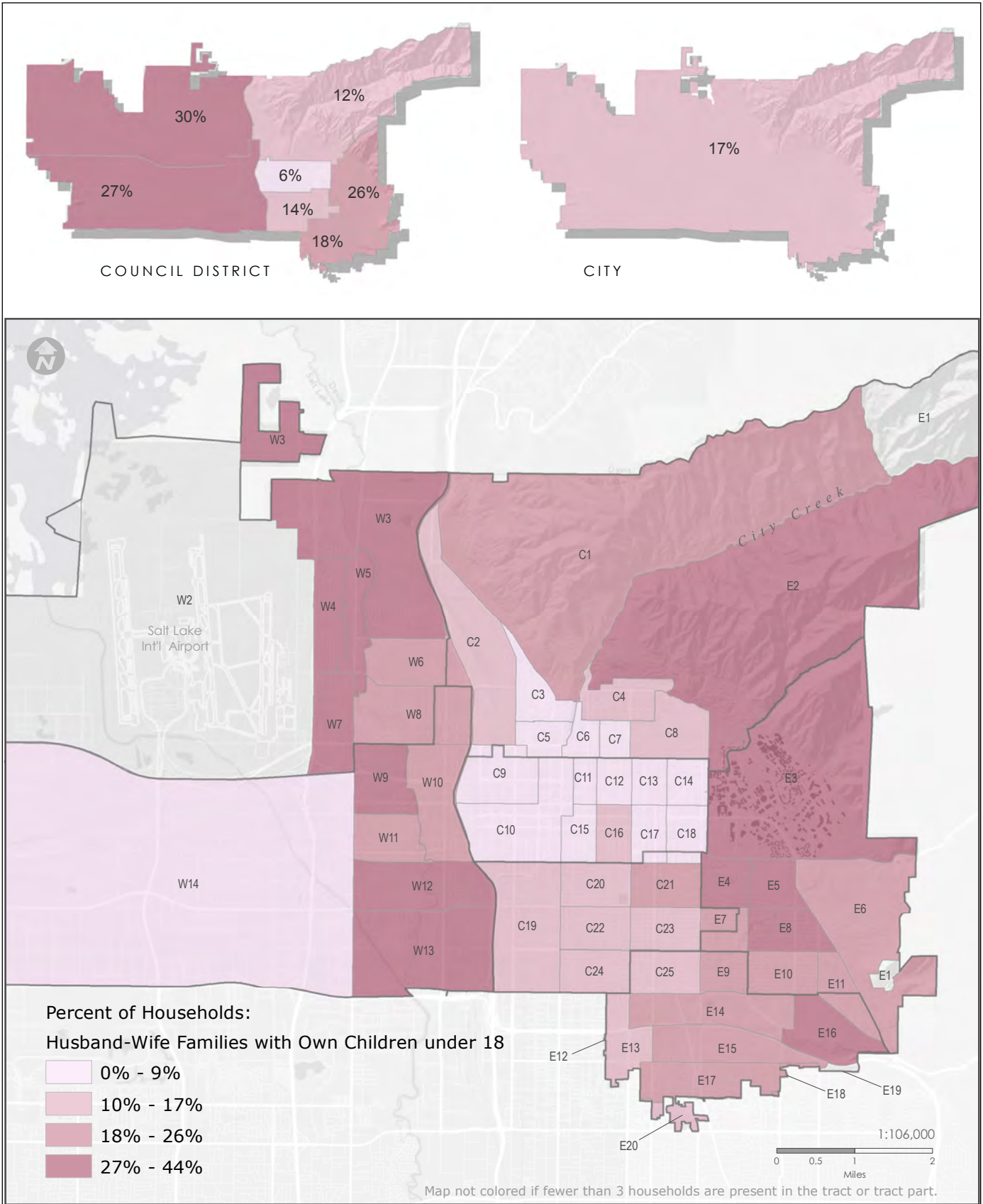

Figure 16: Single Householders with Children under 18 in Salt Lake City, 2010

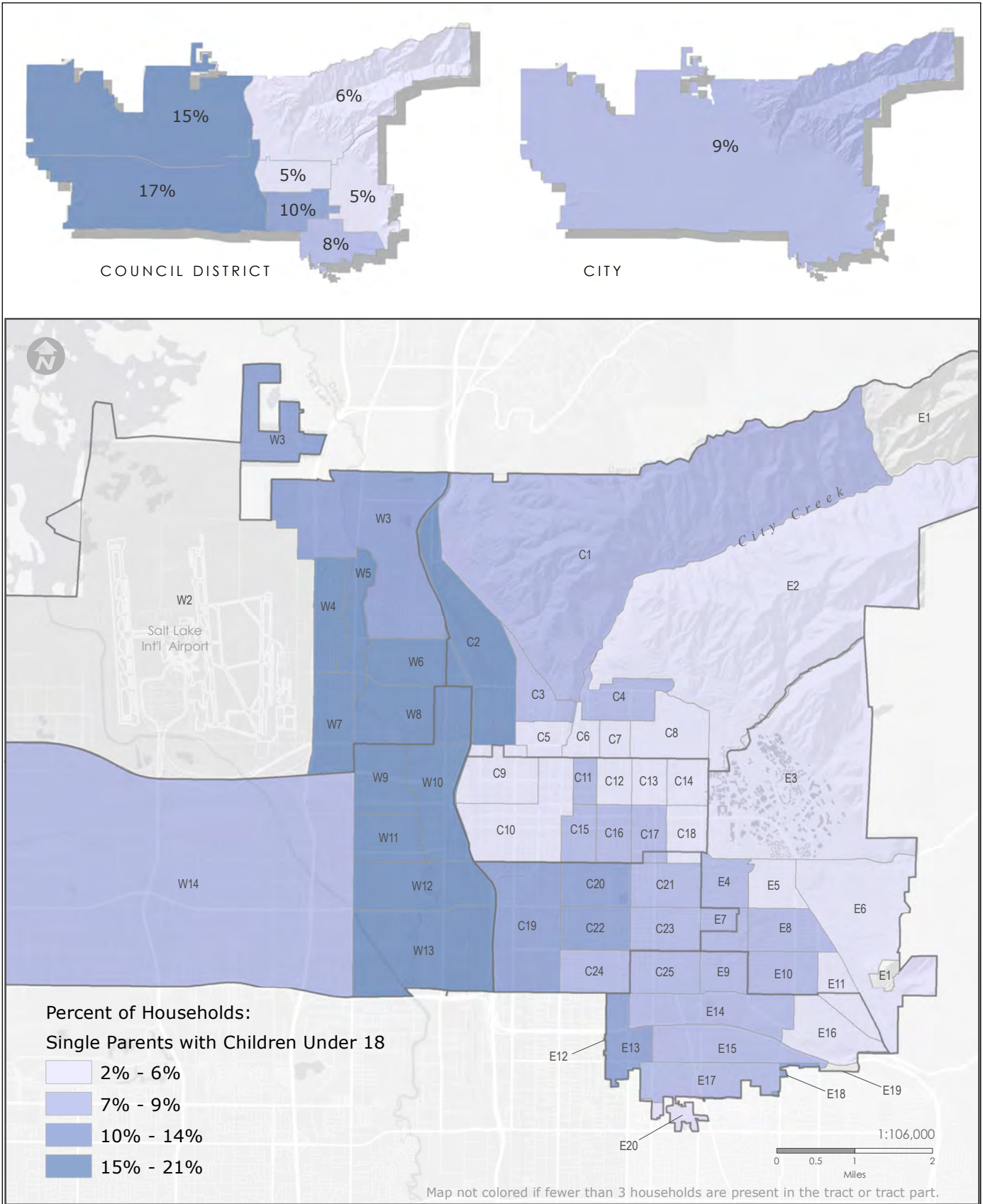

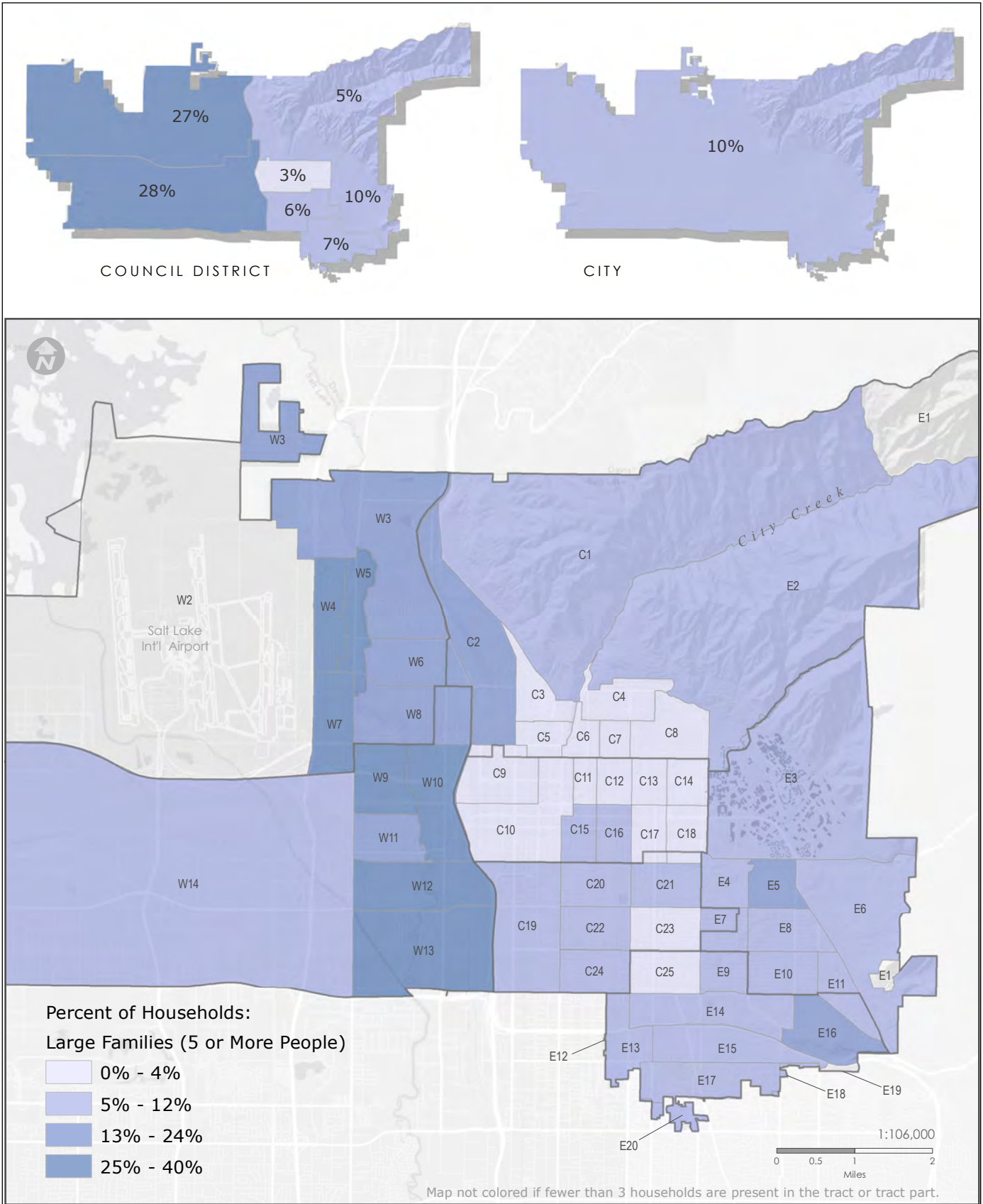

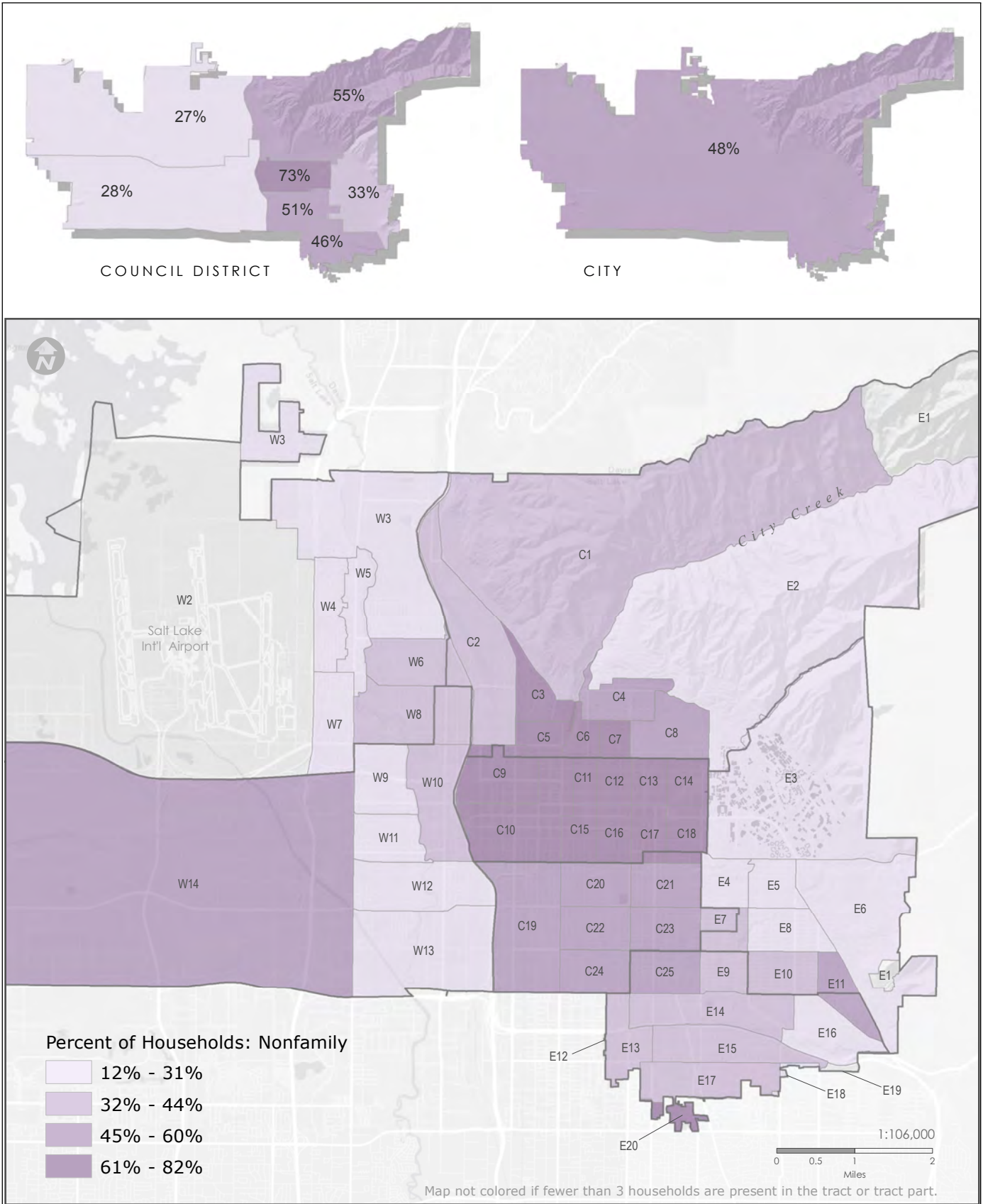

Figure 19: Householders Living Alone in Salt Lake City, 2010

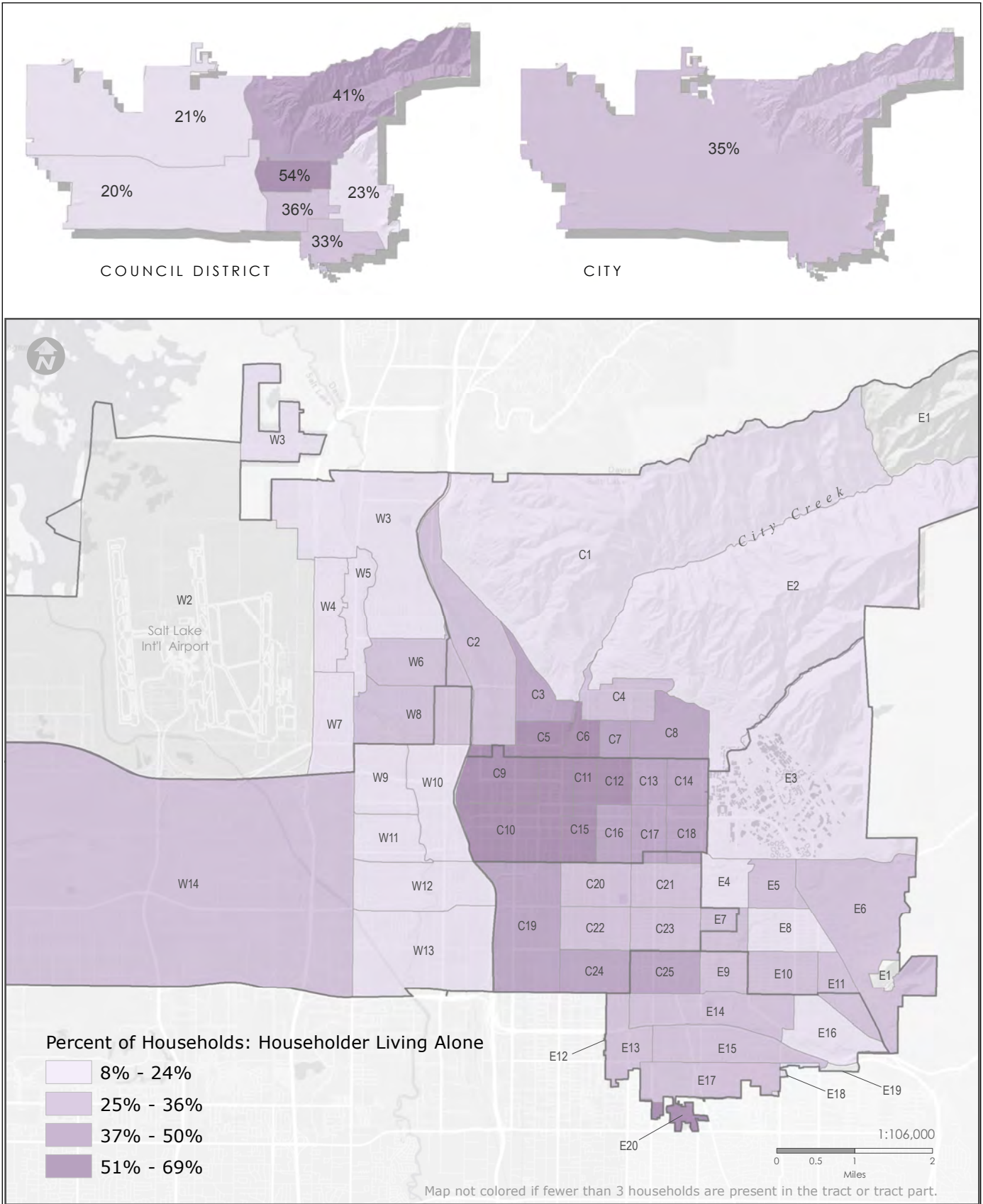

2.3 Housing Affordability

This section presents graphic (Figures 20 through 22) and tabular data (Tables 39 through 44) for median home values, affordable single-family housing units, and affordable single-family housing units within a half mile of TRAX stations. Assessed property values of single-family homes from the Salt Lake County Assessor for the year 2011 is the data set used in these analyses.

The median³ single family home value in Salt Lake City in 2011 is \$203,400. Council Districts 3 and 6 have the highest median home values (\$314,800 and \$334,400 respectively) while Districts 1 and 2 have lowest values (\$137,400 and \$107,600 respectively). The spatial distribution of median home values at the tract level follows these patterns, with values increasing from west to east. Among tracts that meet the minimum population threshold, the extreme values are Tract 1014 in District 6 at a median of \$879,400 and Tract 1140 in District 4 at a median of \$91,700.

The locations of affordable housing in Salt Lake City are almost a mirror image of the median home value. In both cases, assessed values for single-family homes are the data used in the analysis. A detailed description of the definition of affordable is included at the end of this section.⁴ In this analysis, any single-family home with an assessed value of \$255,897 or under is defined as affordable. There are 26,918 affordable units in Salt Lake City in 2011. Districts 1, 2, 5, and 7 contain 21,722 or 80.7 percent of these affordable homes. The fewest affordable single-family homes are located in District 6, with 1,434 units. Considering only sufficiently populated tracts in Salt Lake City, Tract 1028.01 in District 2 has the largest number of affordable homes (1,525). Tract 1014 (District 6), Tract 1021 (District 4), and Tract 1145 (partial tract in District 2) have three or fewer affordable homes.

A total of 2,680 affordable single housing units were identified as being within a half mile of TRAX stations. Council Districts 4 (883 affordable single family homes), 5 (683 affordable single family units), and 7 (762 affordable single family homes) have a combined 2,328 or 86.9 percent of the total within a half mile of TRAX stations. Council District 6 does not have any units that meet these criteria, while the count for Council District 1 is 8, Council District 2 is 306, and Council District 3 is 38. Census Tract 1032 in District 5, located on the city's southern border and near the S-Line Streetcar line, has the largest number of affordable single-family homes within half a mile of a TRAX station at 409 units. Directly to the south is Tract 1049 in District 7 with 302 affordable single-family homes within a half-mile distance of TRAX stations. This includes only the portion of the tract contained in Salt Lake City. Adjacent to Tract 1049 and to the east, Tract 1141, also in District 7, has 233 affordable single family homes within a half mile of TRAX stations. Just to the north is Tract 1033 in District 7 with 208 affordable single-family homes. Tract 1029 in District 5 contains the Ballpark Station and has 277 affordable single-family homes within half a mile of the station. Census Tracts 1016 and 1018 are located in mostly in District 4 and are on the Red Line to the University. They contain 217 and 205 affordable single-family homes within half a mile of TRAX stops, respectively. Census Tract 1006 (mostly within District 1) contains 226 affordable single family units within half a mile of TRAX stations and is located on the North Temple segment of the Airport line.

Affordability is defined here as the single-family unit assessed value threshold that would be affordable to households with 80 percent of the area median income (AMI), assuming that the units were sold at this assessed value. The Salt Lake County AMI for FY 2011 was computed using a formula that was applied to the three-year American Community Survey results for 2006–2008 and adjustment weights and ratios determined by the U.S. Department of Housing and Urban Development.⁵ The rounded 2011 AMI for Salt Lake County was \$70,400, with 80 percent

of this being \$56,320. Income availability is defined as 30 percent of this or \$21,120 at full AMI and \$16,896 at 80 percent AMI. On a monthly basis, this translates to \$1,760 and \$1,408 respectively. After property taxes and insurance, these amounts are reduced to \$1,566 and \$1,253 a month available for mortgage payments. Assuming a 3 percent down payment (\$9,595 and \$7,677), the resulting loan amounts to be financed are \$310,226 and \$248,220. With a mortgage interest rate of 4.5 percent, the maximum home prices are \$319,821 for the AMI and \$255,897 for the 80 percent AMI.

Assessed property values for single family homes in Salt Lake City in 2011 were analyzed and those \$255,897 or under were identified as affordable. Next, a subset of those within a half mile of TRAX stations (following transportation routes) were identified and assigned to census tracts and council district.

in Salt Lake City, 2011**

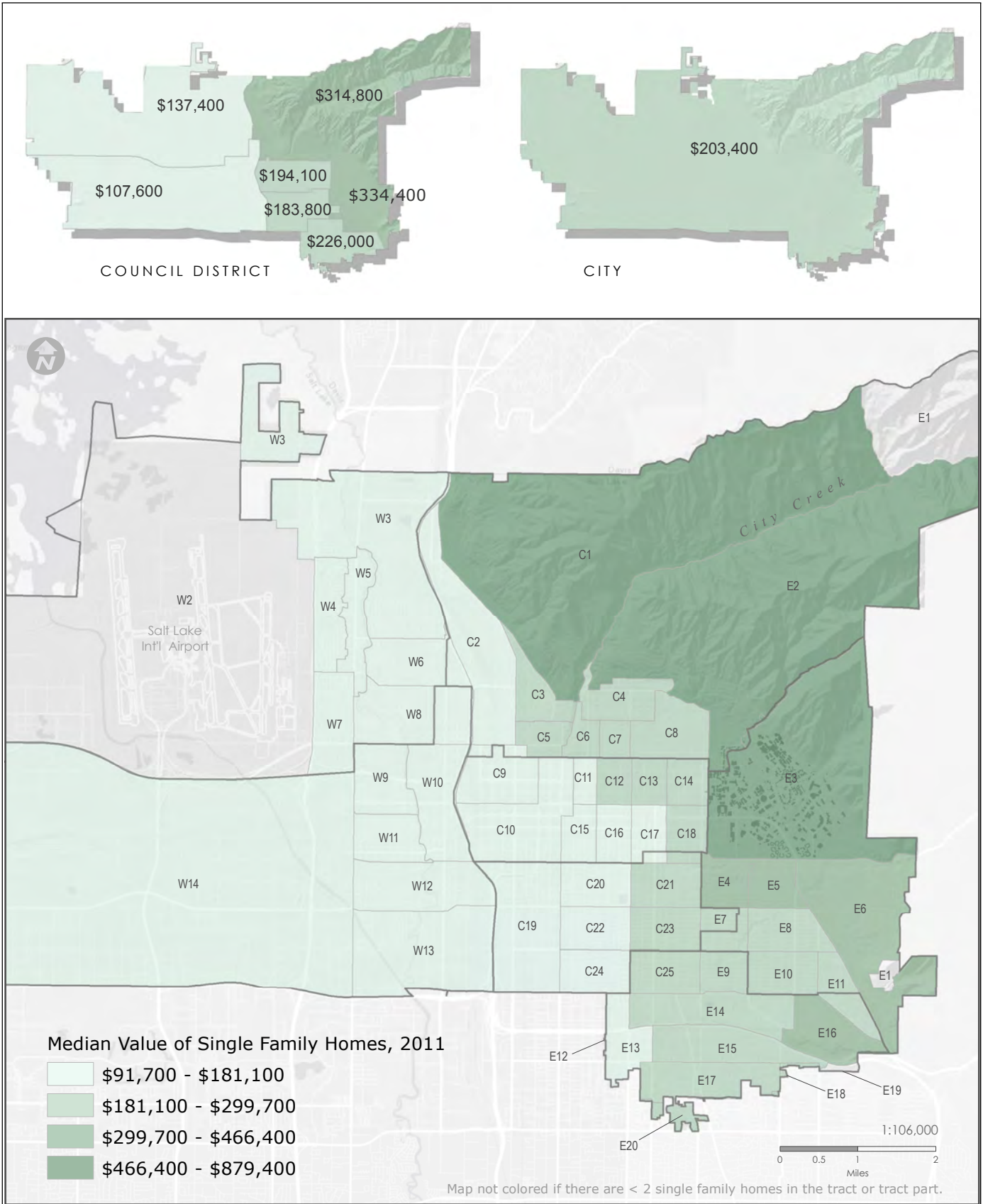

Figure 21: Affordable Single-Family Housing Units in Salt Lake City, 2011

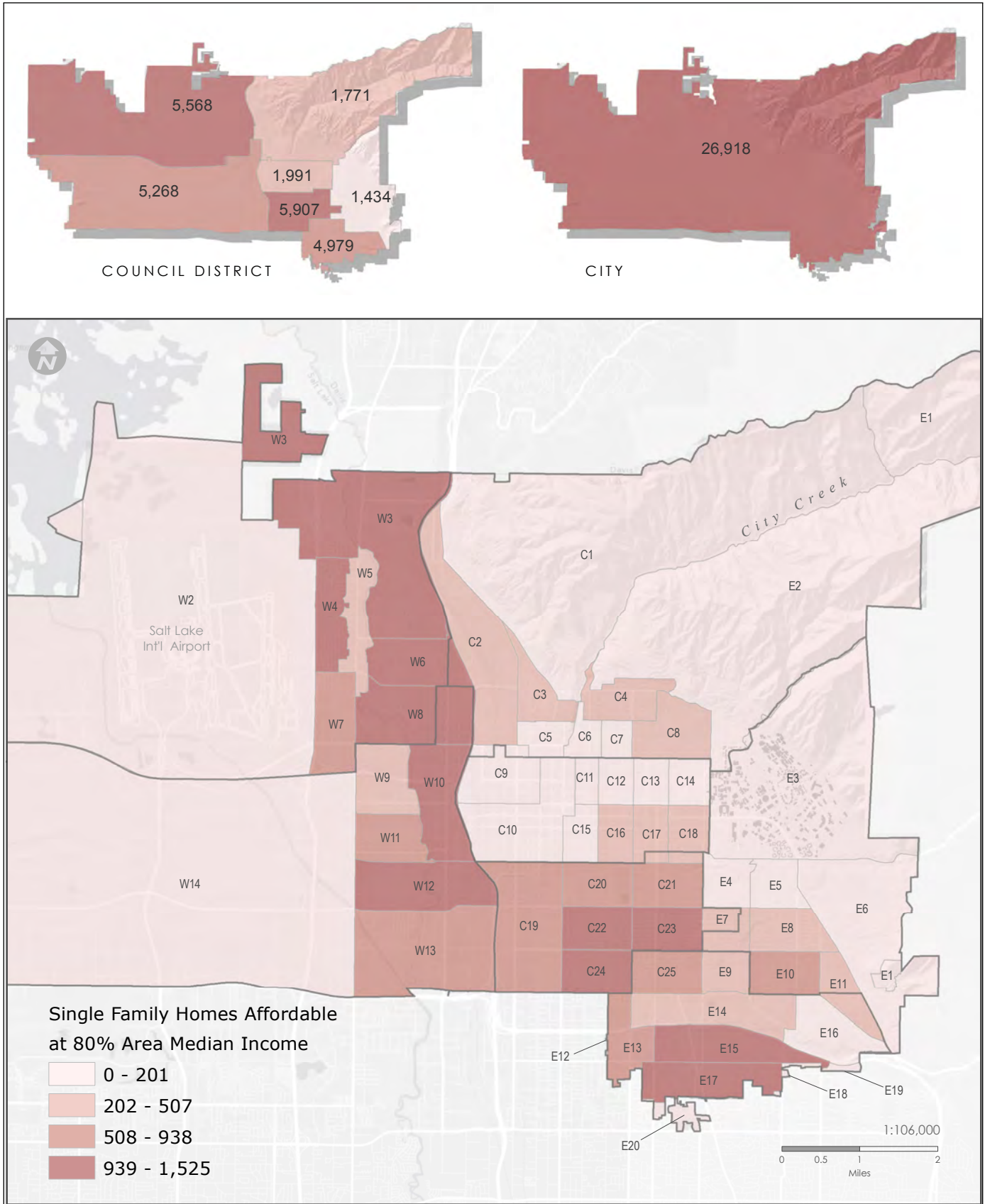

Figure 22: Affordable Single-Family Housing Units within a Half Mile of TRAX Stations in Salt Lake City, 2011

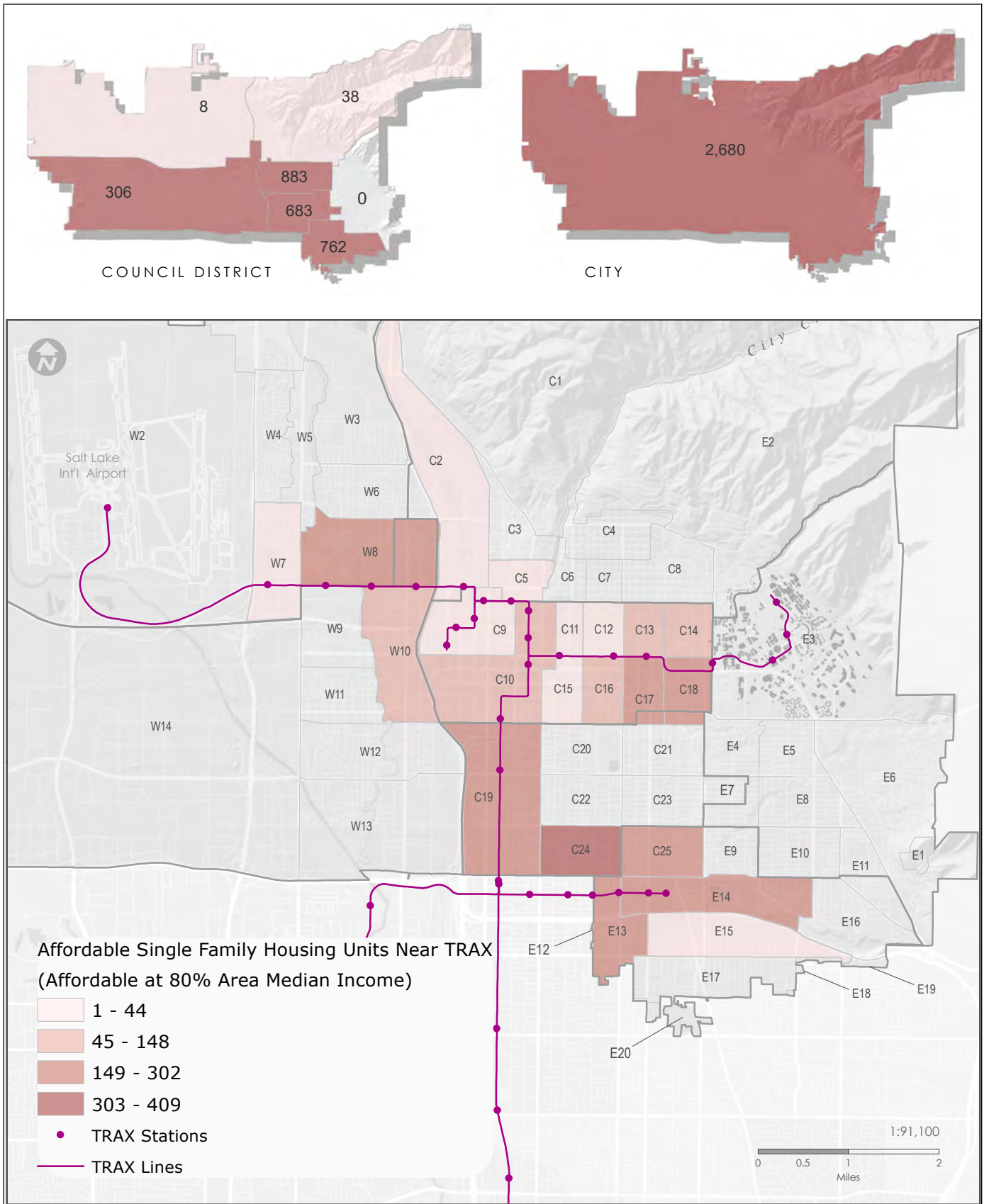

3.1 Age Metrics

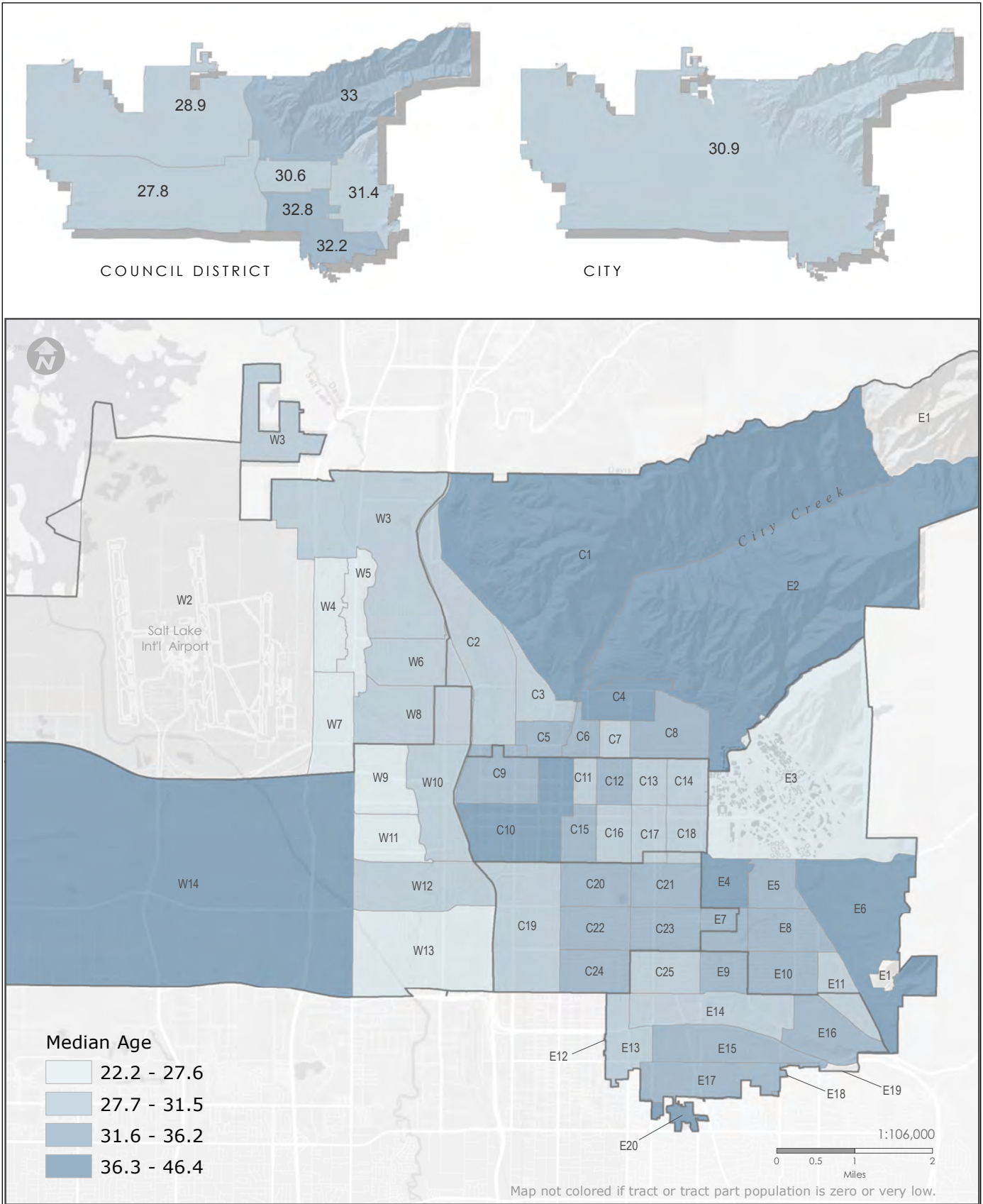
This section presents graphic (Figures 23 through 25) and tabular data (Tables 45 through 50) for median age of the population, the retirement age (at least 65 years old) population, and the population of youth (those less than 18 years old) for census tracts and council districts in Salt Lake City. The data is from the 2010 Census.

Median age of Salt Lake City is 30.9 years old, with the youngest median ages in Council District 2 (27.8 years old) and District 1 (28.9 years old). At the other extreme of median age are District 3 (33.0 years old), District 5 (32.8 years old), and District 7 (32.2 years old). Median age in District 6 (31.4 years old) is somewhat above and for District 4 (30.6 years old) is somewhat below that for the entire city. Census Tract 1014 has the youngest median age in the city (22.2) and contains much of the University of Utah student housing. Tracts 1027.02 in District 2 and 1003.08 in District 1 have the next youngest median ages, with 25.5 years old and 25.7 old respectively. Tracts with the oldest median ages are 1042 (46.4) located in District 6, 1148 (45.9) located in District 3, and 1140 (44.1) in District 4.

The retirement age (at least 65 years old) population of Salt Lake City is 9.4 percent of the total. This share is greatest in Districts 6 and 3, with shares of 12.4 percent and 12.3 percent, respectively. District 2 has 6.7 percent of its population at least 65 years old. This is the lowest share among districts, followed by District 1 (7.4 percent share) and District 5 (7.5 percent share). Of those tracts meeting a minimum population threshold, the tracts with the lowest shares of retirement age persons are Tract 1014 with a 2.2 percent share (University of Utah in District 6), Tract 1003.07 in District 1 (3.3 percent share), and Tract 1003.06 also in District 1 (3.8 percent share). Tracts with the highest shares of persons at least 65 years old are 1118.02 in District 7 (24.4 percent share), 1008 in District 3 (24.2 percent share), and 1042 in District 6 (22.5 percent share).

Youth (persons under 18 years old) are 22.5 percent of the Salt Lake City population. One-third of the populations of Council Districts 1 and 2 are youth, compared to the lowest shares in District 4 (11.0 percent) and District 3 (16.5 percent). Census tracts with the highest share of youth include Tract 1027.02 of District 2 (37.8 percent), Tract 1003.07 of District 1 (37.2 percent), and Tract 1003.08 (36.3 percent) of District 1. Tracts with the smallest shares of youth include Tract 1140 in District 4 with 6.0 percent, Tract 1019 of District 4 with 6.4 percent, and Tract 1008 of District 3 with 6.5 percent.

Figure 24: Percent of Population Age 65 and Above in Salt Lake City, 2010

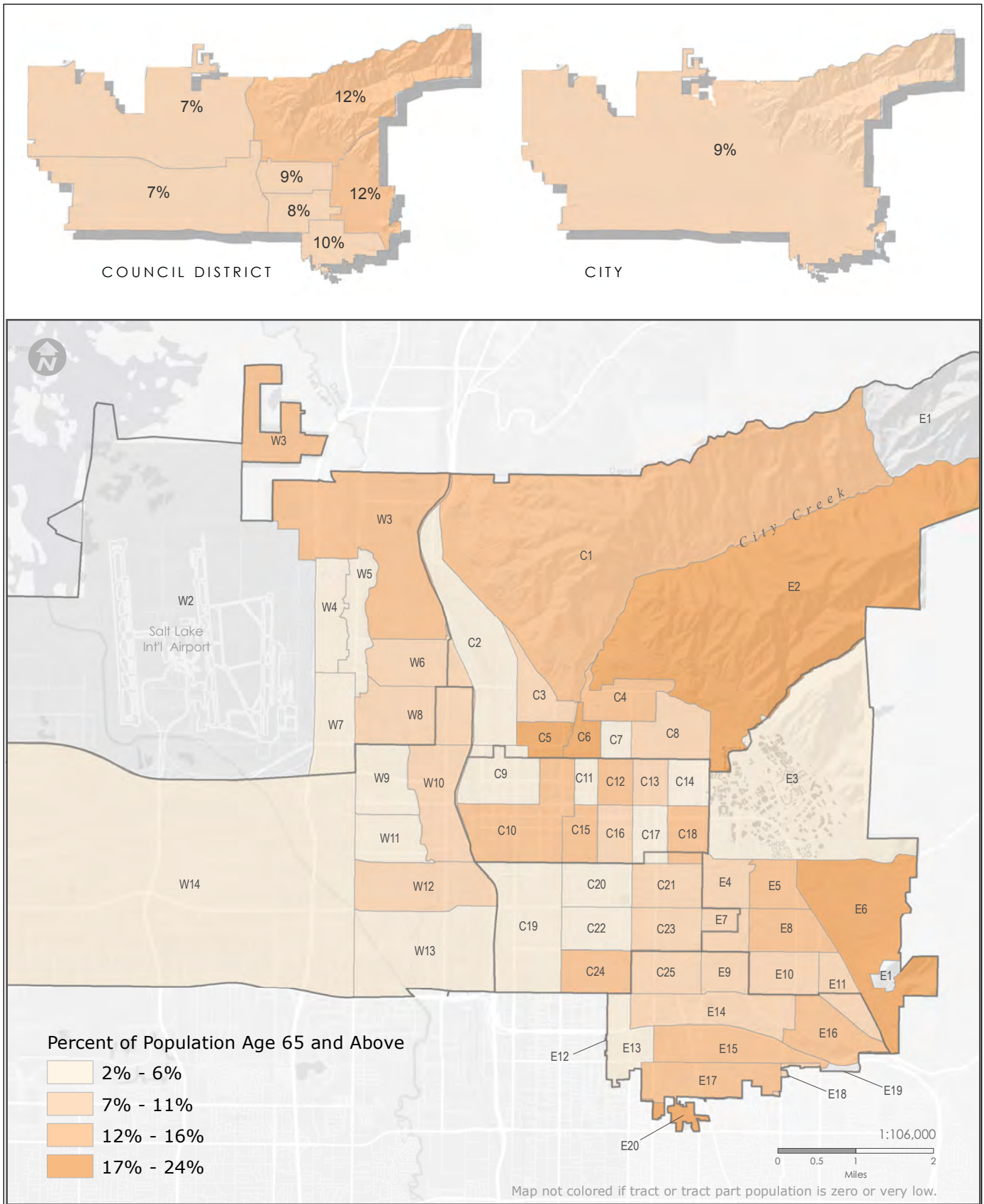

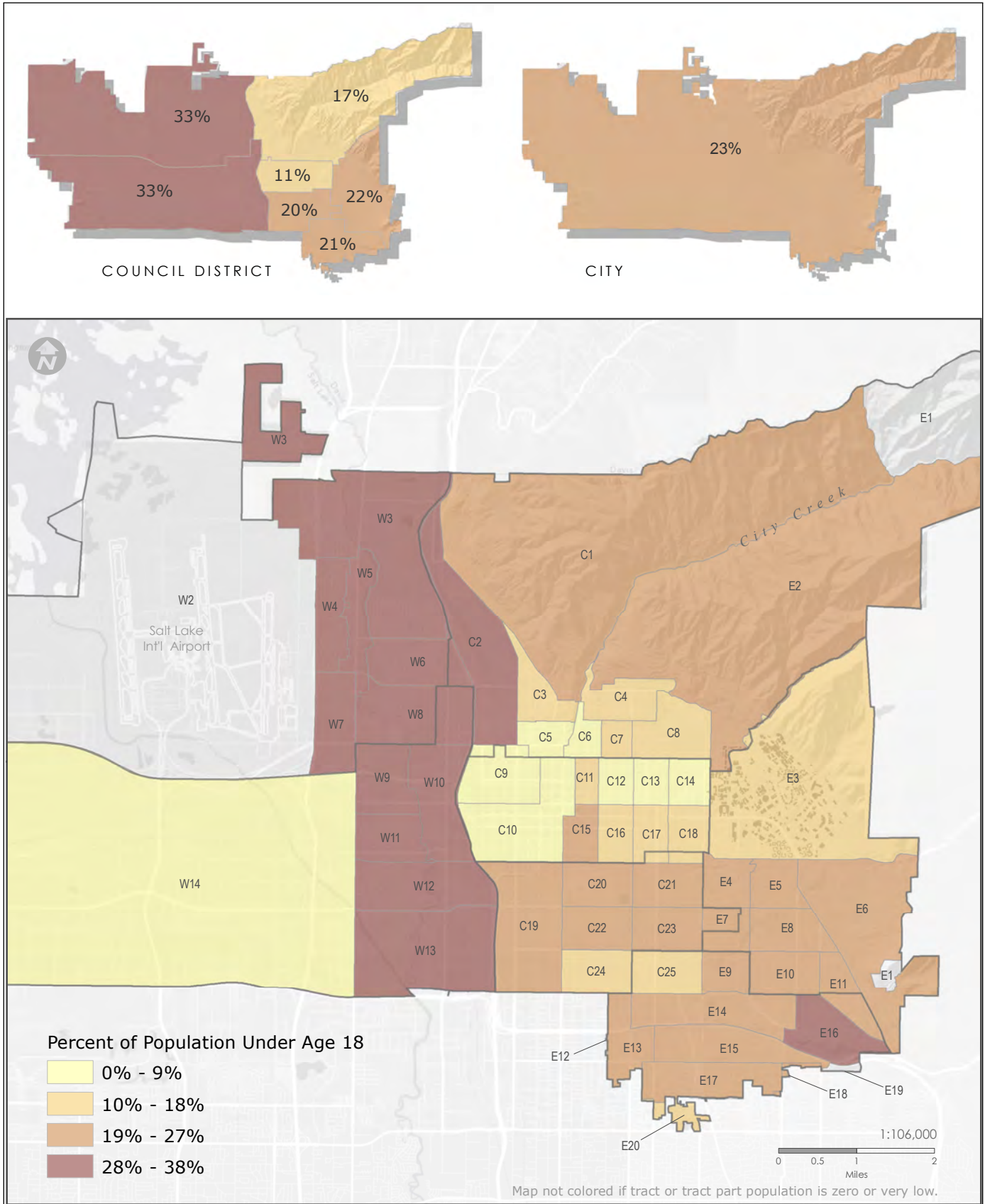

3.2 Group Quarters Population

This section presents graphic (Figures 26 and 27) and tabular data (Tables 51 through 54) for the group quarters population and measures of its proximity to TRAX stations. People not living in housing units were classified as group quarters populations in the 2010 Census. These were divided into institutionalized and noninstitutionalized populations. Institutional group quarters include correctional facilities, nursing homes, other care facilities for the handicapped, and facilities to care for and/or detain juveniles. Noninstitutional facilities include college dormitories, military quarters, group homes, religious group quarters, employment-related housing facilities, and other noninstitutional facilities (e.g., emergency shelters, soup kitchens, YW/MCAs, hostels, etc.).

The total group quarters population in Salt Lake City was enumerated at 4,795 in the 2010 Census. Council Districts 4 and 6 had group quarters population of 1,870 and 1,293, respectively, accounting for two thirds of the city total. Council District 1 and 5 had the smallest group quarters populations, with 129 and 159, respectively. The tract with the largest group quarters population is Tract 1014 in District 6, containing a group quarters population of 1,264, most of which was college student housing. The second largest concentration is in Tract 1025 in District 4, with a group quarters population of 1,016, most of which were classified as “other noninstitutional” facilities, including emergency and transitional shelters for the homeless, residential treatment centers for adults, group homes, workers’ group living quarters, soup kitchens, regularly scheduled mobile food vans, targeted non-sheltered outdoor locations, and domestic violence shelters.⁶

Just less than two thirds (63.4 percent) of the Salt Lake City group quarters population in Salt Lake City are located within a half mile of TRAX Stations. The same council district and tract results as identified above have the largest numbers of group quarters populations that are within a half mile of a TRAX station. Tract 1025 in District 4 has 1,016 group quarters residents within a half mile of TRAX stations. Tract 1014 has 1,185 group quarters residents within a half mile of TRAX stations.

These proximity metrics were calculated by identifying Salt Lake City blocks with any group quarters population. Of that group, blocks within a half mile of TRAX stations (following transportation routes) were identified. Block group quarters populations within the same tract were added together for reporting at a tract level. Similarly, block group quarters populations sharing the same council district were summed to obtain council district totals.

Figure 26: Group Quarters Population in Salt Lake City, 2010

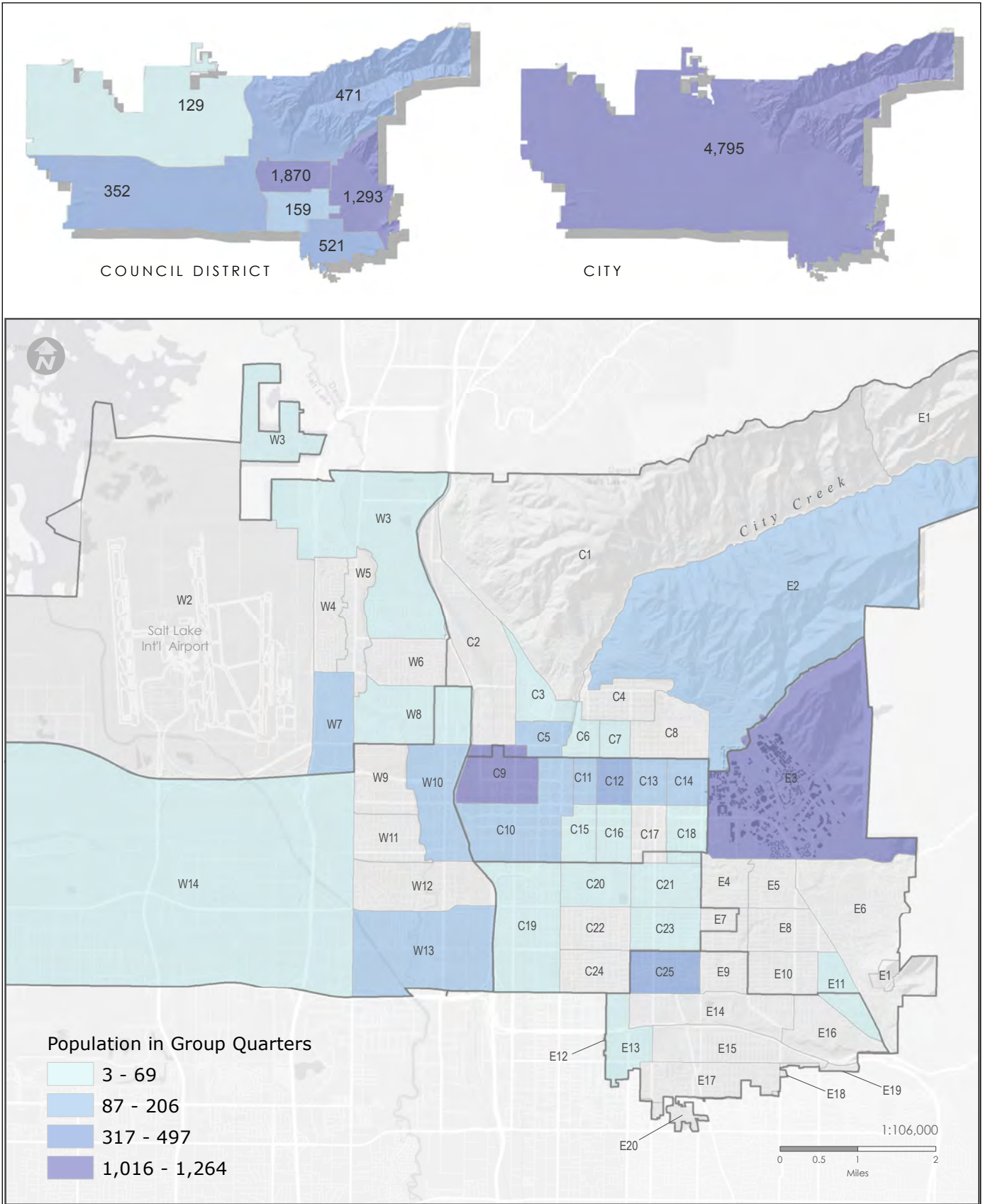

Figure 27: Group Quarters Population within a Half Mile of TRAX Stations in Salt Lake City, 2010

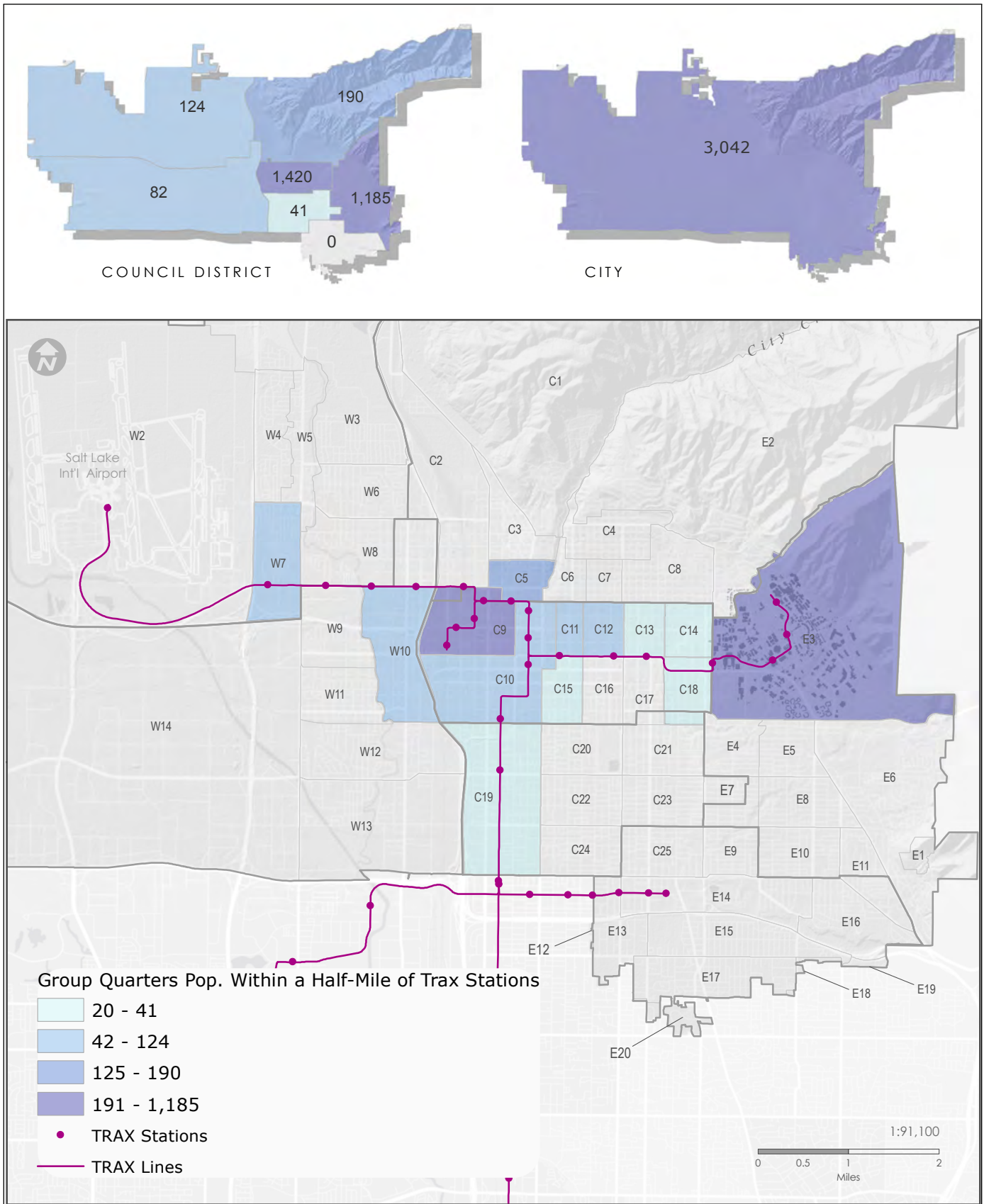

3.3 Socioeconomics

This section presents graphic (Figures 28 through 30) and tabular data (Tables 55 through 60) for households in poverty, the foreign-born population, and median household income. These period estimates are derived from the 2008-2012 American Community Survey. The values span the five-year period and are based on sample data. Accompanying each estimate is information on the reliability of the estimate and the implied sampling error. The measure of uncertainty presented here is the coefficient of variation (CV) and it should be considered when interpreting the meaning of the point estimates. These particular coefficients of variation are expressed at the 90 percent confidence level. Smaller CVs indicate that the estimate is a more reliable estimate of the population. For example, suppose a point estimate of a population is 100 persons and the CV is 0.10 at the 90 percent confidence level. This is interpreted to mean that there is a 90 percent probability that the actual population is between 90 and 110.⁷ Census tracts are the smallest geography for which these data are produced. These do not completely correspond with Council District boundaries. This is the reason that data are presented for census tracts but not council districts.⁸

Poverty is defined as annual income below a set of poverty thresholds. These thresholds vary according to family size, the number of related children, and the age of the householder. If the before-tax income of a family is less than the corresponding poverty threshold, then the household and all individuals within it are designated as being in poverty. The official thresholds are updated annually but do not vary geographically.⁹ In the 5-year ACS for 2008-2012, it is estimated that 13,241 households within Salt Lake City are living in poverty. Of those tracts best matching the Salt Lake City boundary, Tract 1029 within Council District 5 has an estimated 830 (CV = 0.12) households below the poverty level, the highest point estimate among tracts. Other tracts with estimated large numbers of households in poverty are Tract 1032, also in District 5 (640, CV = 0.16), Tracts 1014 (542, CV = 0.14), Tract 1006 in Districts 1 and 2 (536, CV = 0.21), and Tract 1016 (514, CV = 0.14) in or adjacent to the University of Utah, and Tract 1023 (503, CV = 0.16) in District 4.

Persons who are not U.S. citizens at birth are foreign born.¹⁰ An estimated 32,927 (CV = 0.03) foreign-born reside in Salt Lake City. Tracts with the largest estimated populations of foreign-born are in Districts 1 and 2, where the majority of tracts have estimated foreign-born populations exceeding 1,000 and up to 2,236. The University of Utah tract also has a large estimated foreign-born population (1,129, CV = 0.16).

Annual household income is the sum of all pre-tax monetary income of the residents of the household for a specified year. It includes income from labor (wages, salaries, etc.) and non-labor sources (transfers (Social Security, disability, pensions), rent, dividends, interest, etc.)¹¹ Median household income is computed as the value where the incomes of half of the households are above and half below. Estimated median income for 2008-2012 is \$44,510 (CV= 0.02) for Salt Lake City. Census Tract 1148 in District 3 has an estimated median income of \$188,750 (CV = 0.09), the highest among all tracts in Salt Lake City. Other high median household income tracts are located in Districts 3, 6, and 7. Lowest estimated median household income tracts are mainly in Districts 4 and 5.

⁷The coefficient of variation (CV) is the relative amount of sampling error and is the ratio of the standard error and the point estimate. This is expressed in percentage terms. This allows for the comparison of sampling errors between different estimates. In general, larger sample sizes are more reliable and have lower CVs. Small sample sizes may generate estimates that are unreliable. Figure 28: Households in Poverty in Salt Lake City, 2008–2012

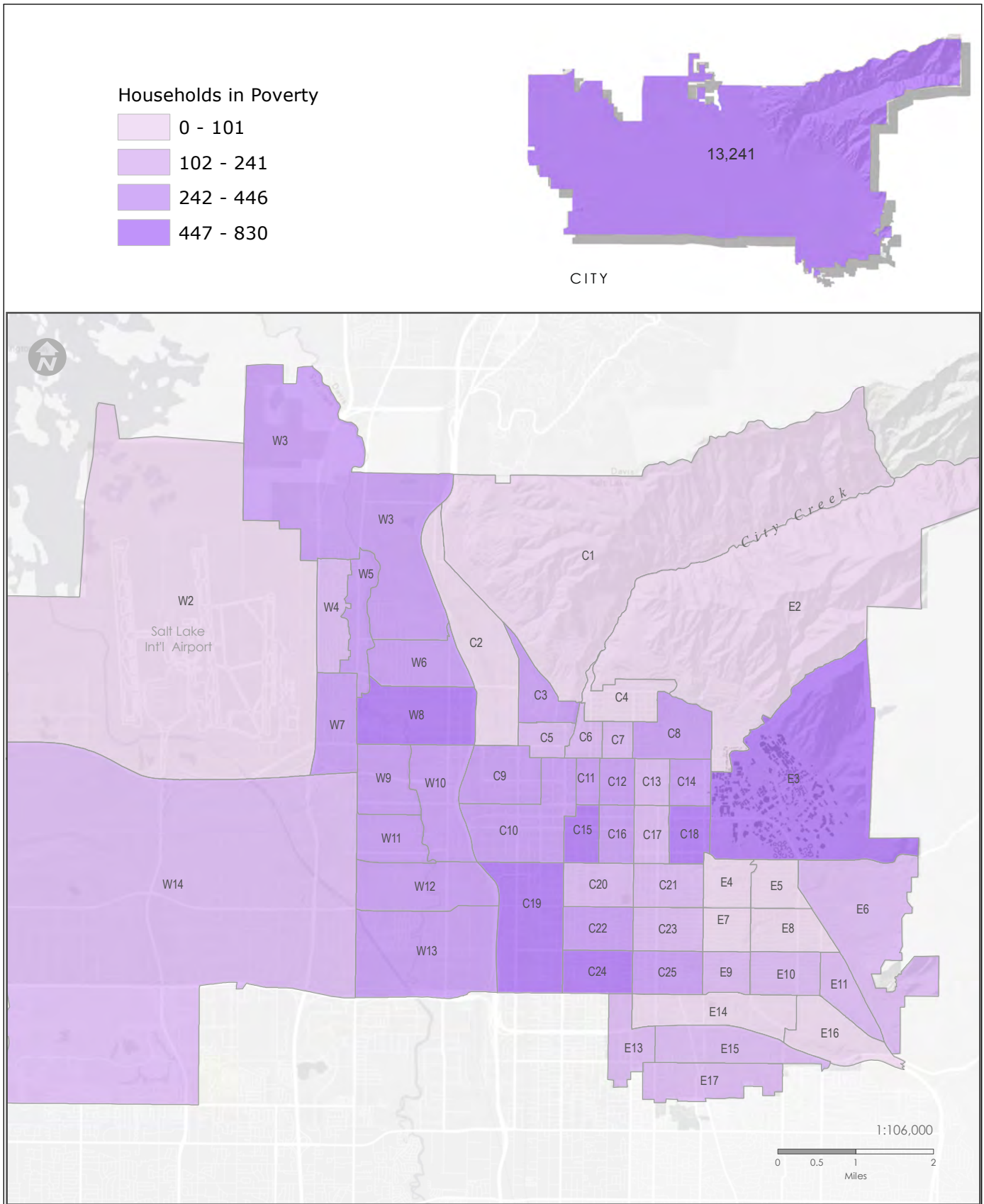

Figure 29: Foreign-Born Population in Salt Lake City, 2008–2012

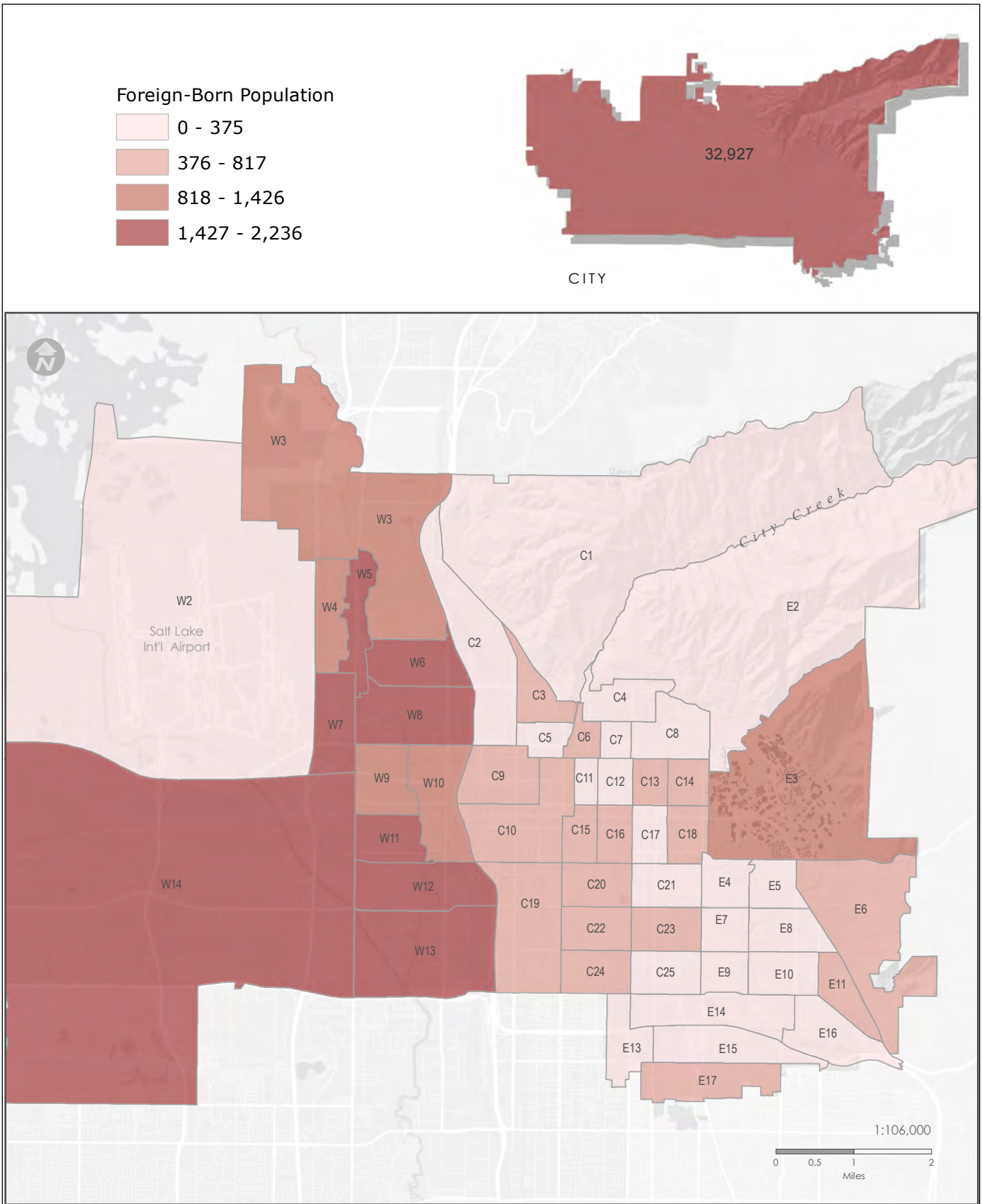

Figure 30: Median Household Income in Salt Lake City, 2008–2012

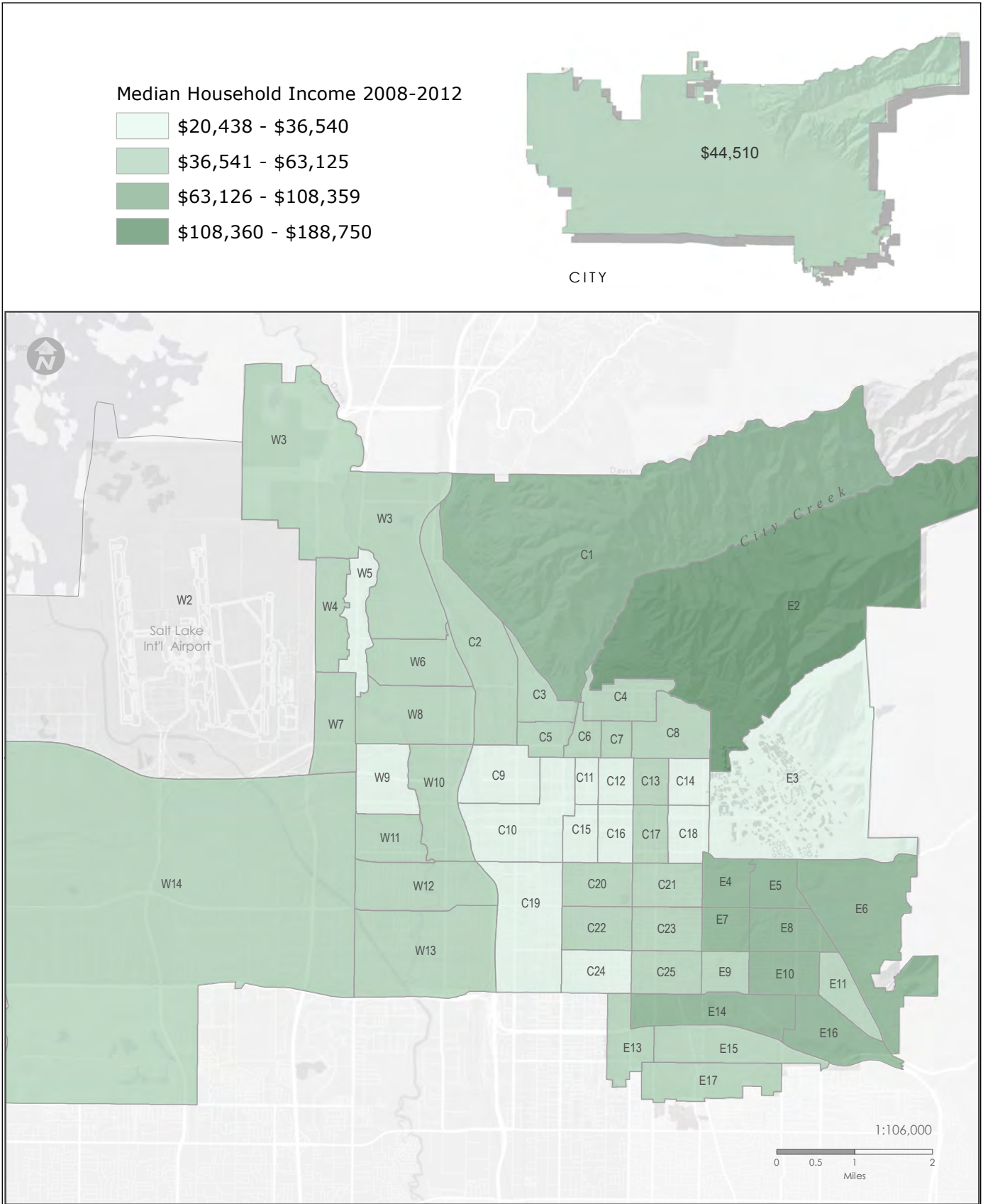

3.4 Homeless Population

This section presents graphic (Figure 31) and tabular data (Table 61 and 62) for the population in selected types of homeless housing for a point-in-time count conducted in January 2013. The point-in-time count is a census of all homeless persons living in emergency shelters, transitional housing, and on the streets for the night of the count. It is conducted annually at the end of January.¹² Note that unsheltered populations are not enumerated in the maps and tables in this section.

Point-in-time counts are conducted for several types of homeless housing, comprising emergency shelters, transitional housing, safe havens, rapid re-housing and permanent supportive housing. Not every housing type is included in the tract and council district totals presented in this section. Emergency shelters, transitional housing and safe haven counts are included wherever assignment to an address was possible. Populations from three emergency shelter or transitional housing programs in Salt Lake City could not be included due to the scattered nature of housing through these programs. There were 96 individuals from these programs who are not included in tract or council district totals, because the share of that number living within Salt Lake City boundaries and their location is unknown. The populations in rapid re-housing and permanent supportive housing are also not included. Rapid re-housing assigns individuals to varying locations, lacking a set address. Individuals in permanent supportive housing are considered housed.

Homeless housing shelters and programs were matched with an address representing the actual location of the population counted for the shelter or program. Populations at each location were aggregated to Salt Lake City census tracts or tract parts for presentation of the data. Council district totals were also aggregated in the same fashion.

Council District 4 has the vast majority of the Salt Lake City population in homeless emergency shelters and transitional housing, with 1,073 of the 1,280 persons enumerated in the point-in-time count. Other populations were counted in Districts 5 (129 persons), District 1 (60 persons), and District 2 (18 persons). Tract 1025 in District 4 had 666 persons in homeless emergency shelters and transitional housing, the most of any tract in the city. Other tracts with significant populations of the homeless are Tract 1021 of District 4 (237 persons) and Tract 1030 of District 5 (108 persons).

Figure 31: Population in Homeless Emergency Shelters and Transitional Housing in Salt Lake City, 2013

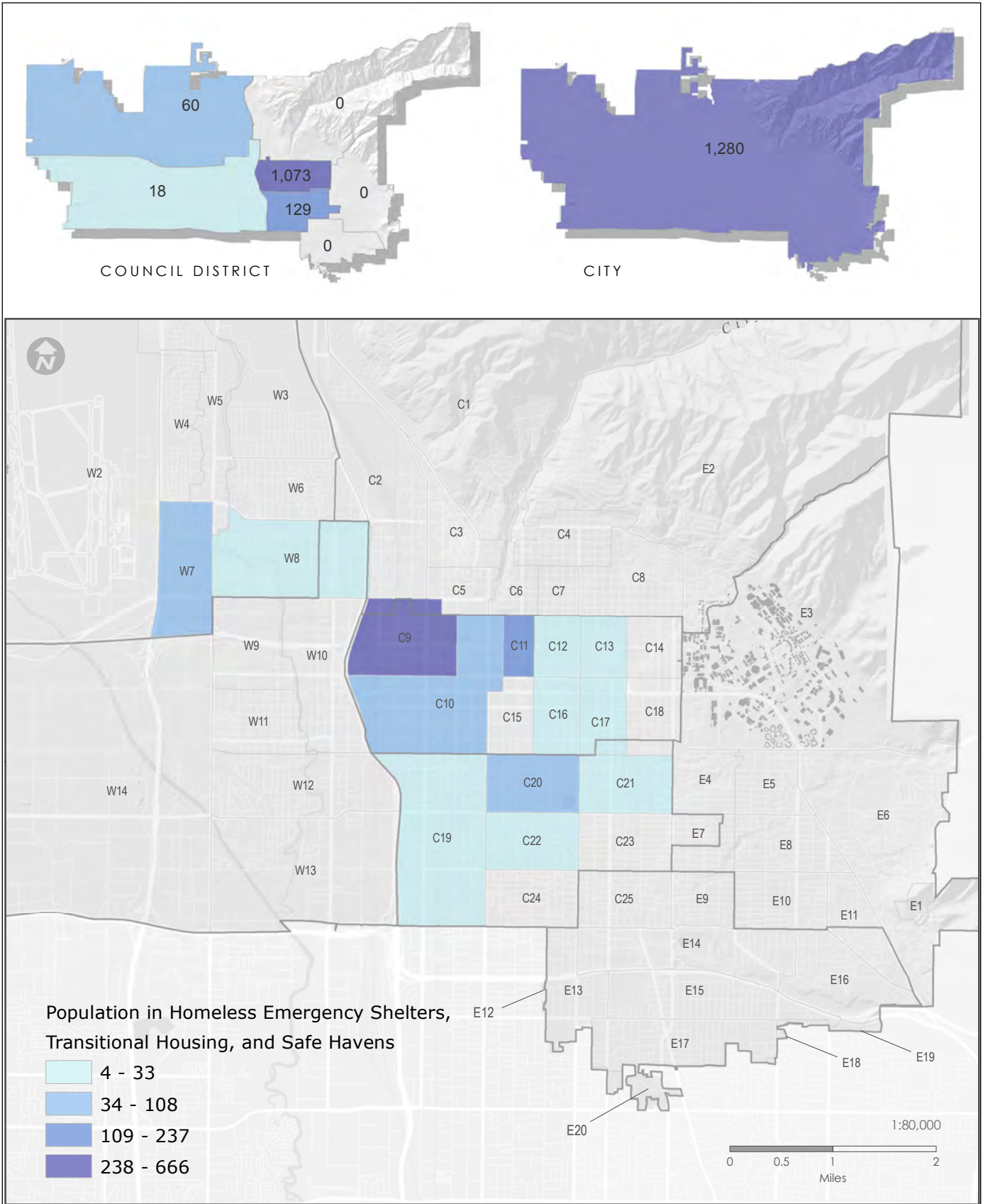

CHANGE PRODUCTS

4.1 Population Change

This section presents graphic (Figures 32 and 33) and tabular data (Tables 63 through 66) for the change in total population and population 65 years and older from 2000 to 2010.

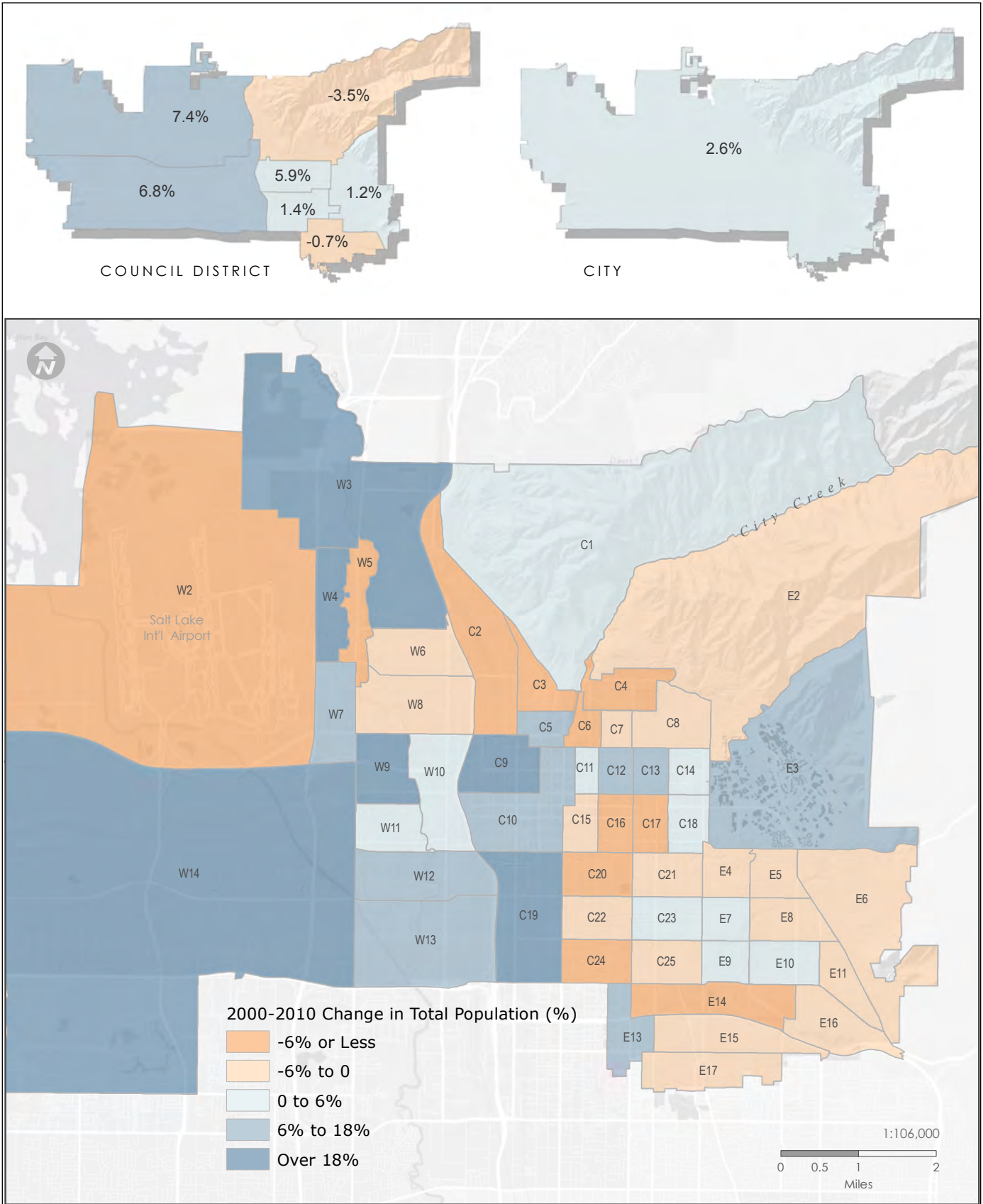
All data has been translated to the 2010 census tract and 2010 council district geographies. The entire 2010 census tract geography, including the parts inside and outside of Salt Lake City, is included in the change products. Comparable data from the 2000 Census was aggregated to the 2010 tract and 2010 council district geographies so that the comparisons could be made. Details of the procedure are below.

The Salt Lake City population increased from 181,775 to 186,440 from 2000 to 2010, an increase of 2.6 percent or 4,665 persons. Over this same period of time, Council District 1 increased by 7.4 percent or 1,906 persons, Council District 2 increased by 6.8 percent or 1,734 persons, and Council District 4 increased by 5.9 percent or 1,481 persons. The populations in Districts 5 and 6 increased by 364 and 328 persons, respectively. Meanwhile, District 3 population declined by 961 and District 7 declined by 187. Of the tracts best matching the Salt Lake City boundary, the largest population gains from 2000 to 2010 were in Tract 1025 (mostly in Council District 4) with an increase of 1,880 persons or 119.0 percent and Tract 1029 of District 5 with an increase of 1,217 persons or 37.1 percent. Tracts with population declines were more dispersed throughout the city with the largest absolute population declines in Tract 1020 of District 4 (decrease of 451), Tract 1007 of District 3 (decrease of 359), Tract 1032 of District 5 (decrease of 345), and Tract 1005 of District 1 (decrease of 343).

From 2000 to 2010, Salt Lake City experienced a decline of the population 65 years and older of 2,409 or 12.1 percent. The 2000 population 65 years and older was 19,925 and that of 2010 is 17,516. Among the City Council Districts, largest declines were in District 7 (a decrease of 874) and District 5 (a decrease of 651). While all Council Districts had declining populations of persons at least 65 years old, the declines were minimal in District 3 (minus 4) and District 4 (minus 6). The largest numeric declines of the population 65 years and older were in Tract 1032 of District 5 (with a loss of 270), Tract 1048 of District 7 (with a loss of 267), and Tract 1047 of District 7 (with a decline of 213).

The summary files from Census 2000 and 2010 were used to generate all of the change products in this and the remaining sections of this document. The comparability of data between different years (e.g. Decennial Census 2000 and Decennial Census 2010) is not always straightforward since the data is aggregated to geographical areas that may change over time. The changes in data values, absolute and percentage, between the Decennial Census 2000 and Decennial Census 2010 that are reported in this document are based on a normalization of Census 2000 geographical areas to Census 2010 geographical areas. The normalization allows the data to be tabulated for different geographical areas. The normalization procedure used here involves grouping Census 2000 Blocks together to build areas that have external boundaries that approximate the various Census 2010 geographical areas such as Census 2010 places, council districts, and tracts). The data for the Census 2000 blocks is then aggregated to generate Census 2000 data for geographies approximating the Census 2010 geographies. Because Salt Lake City is densely populated, Census 2000 blocks in Salt Lake City tend to be small in area. For this reason, the approximations built out of these blocks ranged from very good to excellent for geographical units in Salt Lake City.

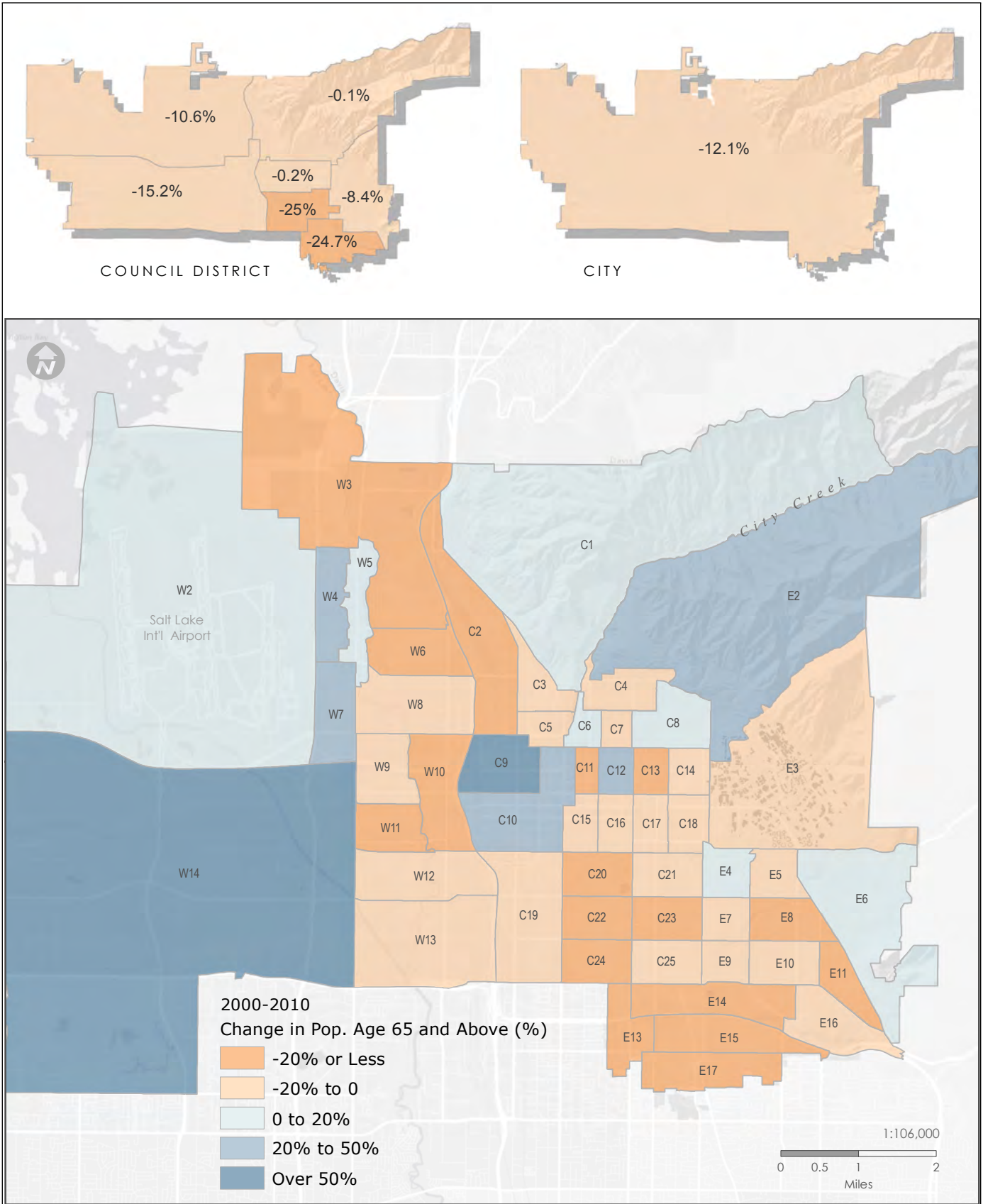

4.2 Household Change

This section presents graphic (Figures 34 through 37) and tabular data (Tables 67 through 74) for the change in total households, renter-occupied units, owner-occupied units, and single parent households from 2000 to 2010.

All data has been translated to the 2010 census tract and 2010 council district geographies. The entire 2010 census tract geography, including the parts inside and outside of Salt Lake City, is included in the change products. Comparable data from the 2000 Census was aggregated to the 2010 tract and 2010 council district geographies so that the comparisons could be made. Details of the procedure are presented in the previous section.

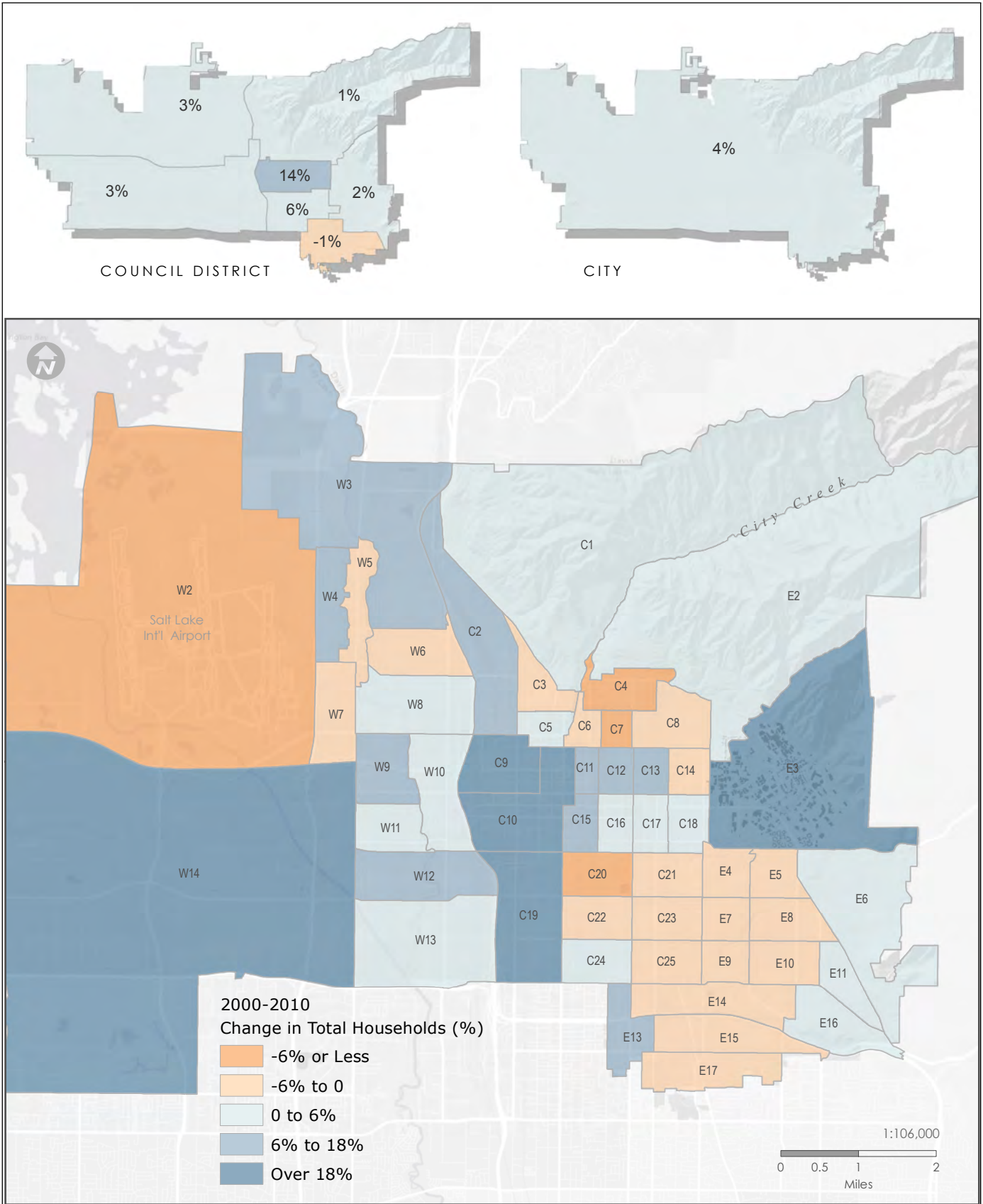
From 2000 to 2010, the total number of households in Salt Lake City increased from 71,473 to 74,513. This is an increase of 3,040 or 4.3 percent. Council District 4 had the largest increase (1,735 or 14.0 percent), followed by Council District 5 (640 or 6.0 percent). All other districts except District 7 also experienced increases in households, with magnitudes ranging from 73 to 249. District 7 had 122 fewer households in 2010 as compared to 2000. Of the tracts best matching Salt Lake City boundaries, the largest increases were located in Tract 1025, mostly in District 4, with an increase of 998 households, and Tract 1029 of District 5, with an increase of 783 households. Tracts with declines were more geographically dispersed, with the greatest losses in Districts 3, 5, and 7.

Renter-occupied units in Salt Lake City increased by 3,571 or 10.2 percent from 2000 to 2010, rising from 34,869 to 38,440. All council districts had increases, although District 4, with an increase of 1,267 units by far had the largest increase. In contrast, District 3 had the smallest increase, with 59 more renter-occupied units in 2010 as compared to 2000. Tract 1025, mostly in District 4, had the largest increase of 825, followed by Tract 1029, located in District 5, with an increase of 788.

In contrast, owner occupied units in Salt Lake City decline by 531 over the same period, from 36,604 to 36,073. All Council Districts, except District 4, which increased by 468, and District 3, which increased by 14, had declines. The largest declines were in District 7 (decline of 355) and District 6 (decline of 234). Tracts with the greatest increase in owner-occupied units are in Tract 1025 (mostly in District 4) with an increase of 173 and Tract 1140 of District 4, with an increase of 171. Tracts with the largest numeric declines were Tract 1048 of District 7 (minus 158), Tract 1003.08 of District 1 (minus 113), and Tract 1047 of District 7 (minus 102).

Single parent households increased slightly, from 6,393 in 2000 to 6,480 in 2010. These 87 additional households were concentrated in Districts 1 and 2, while there were declines especially in District 4, and, to a lesser extent, Districts 6, 7, and 3. Small changes, both positive and negative, were dispersed throughout the city.

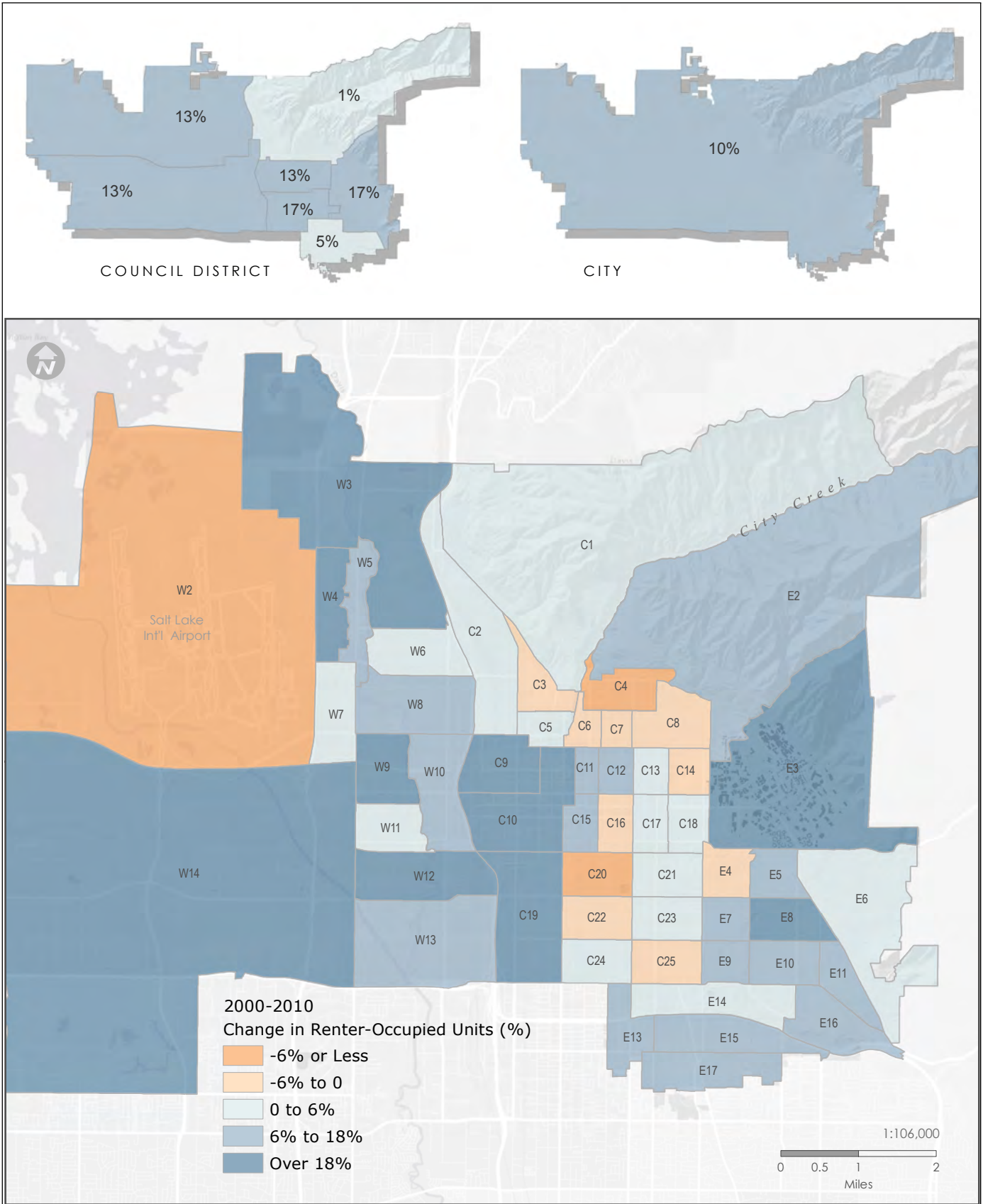

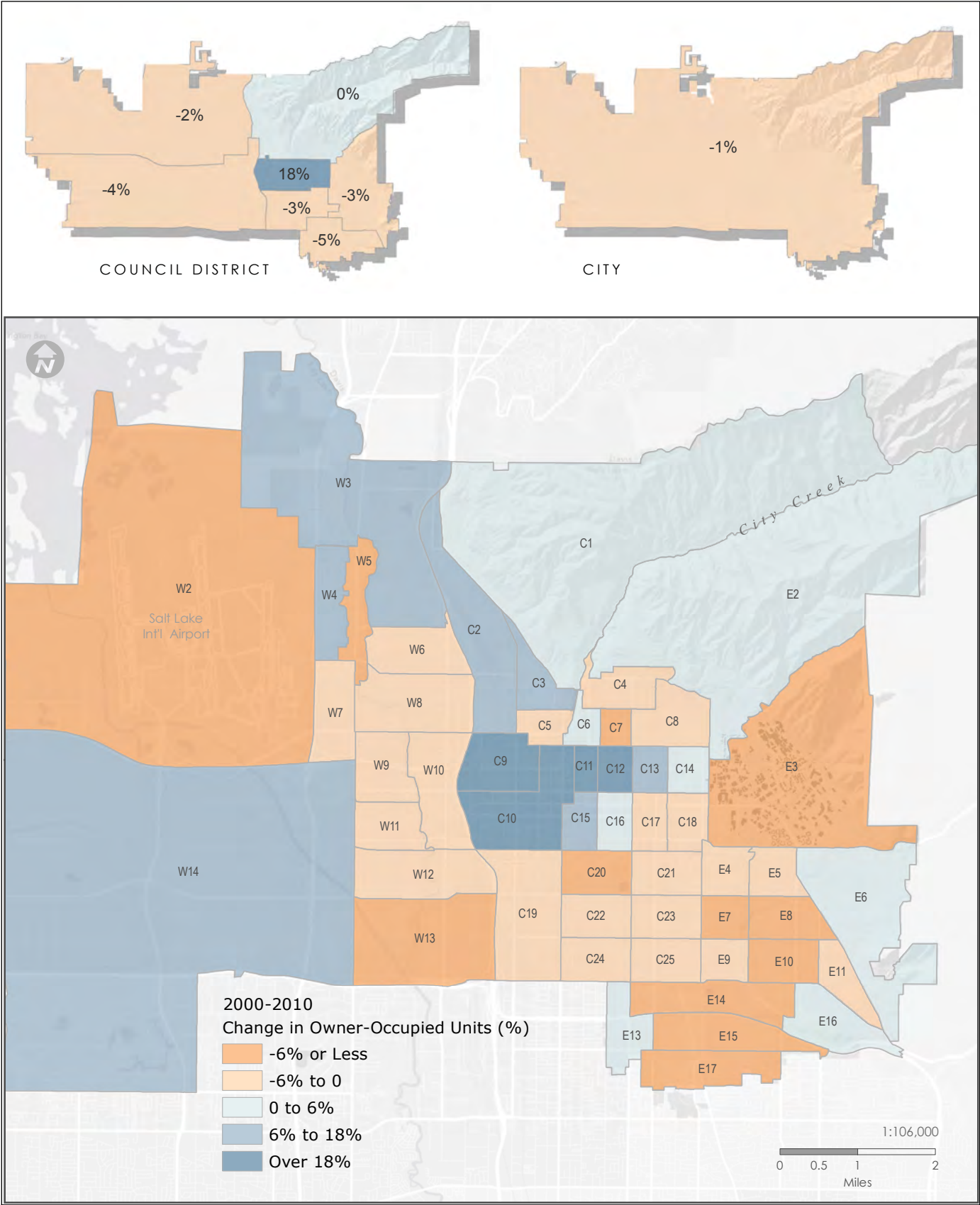

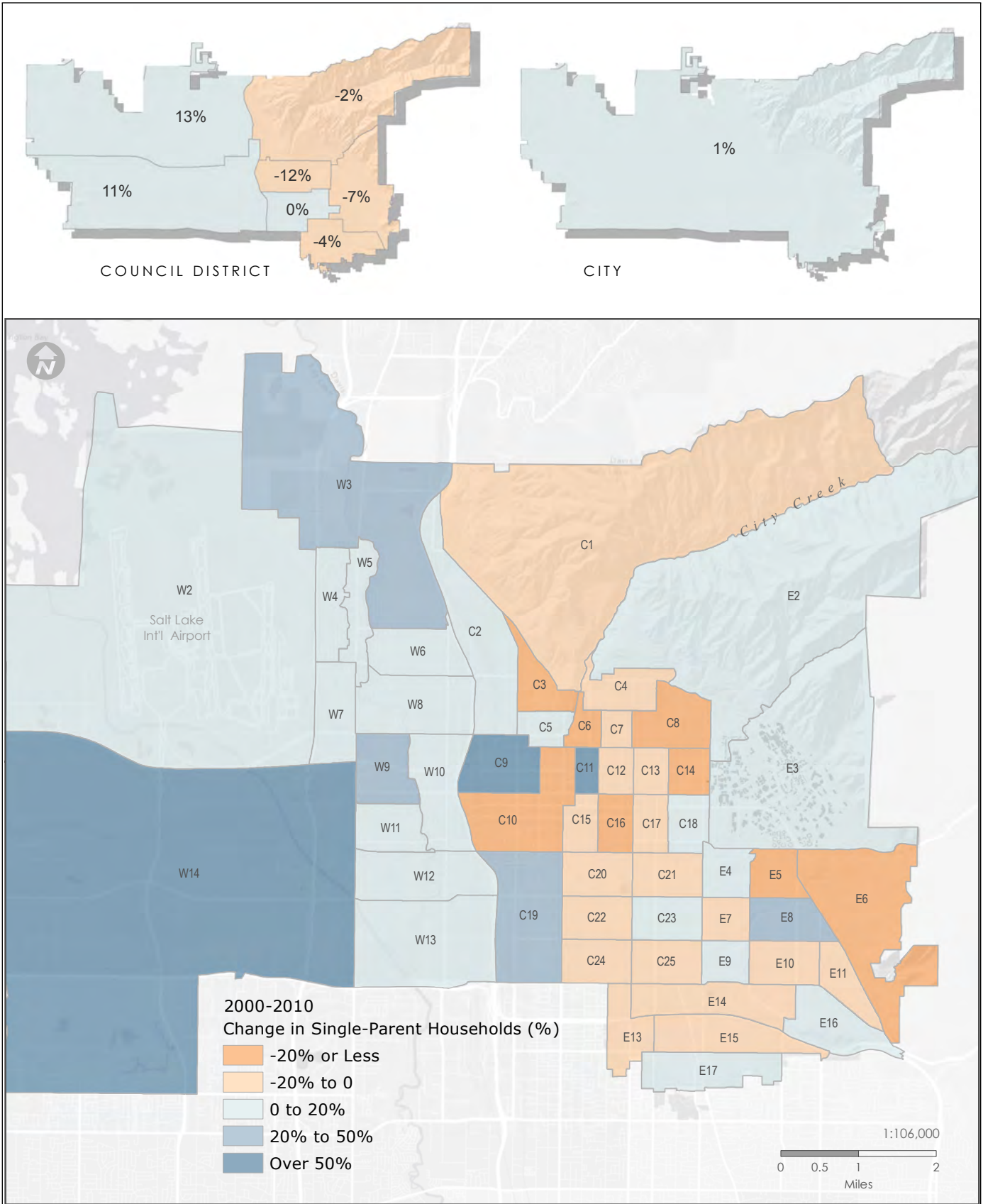
