# Utah Long-Term Planning Projection Summary

# Sanpete County




Sanpete is the 13th largest county in Utah, with a 2020 Census population of 28,437. Between 2010 and 2020, Sanpete County grew by 615 residents, driven by natural increase.

Sanpete County's population is projected to grow from 28,560 on July 1, 2020 to 40,096 in 2060. The median age is projected to rise from 27.2 in 2020 to 29.3 in 2060, the second youngest in the state. Additional details on age groups are included below.

Sanpete County's economy ranks among Utah's more economically diverse economies. Analysts expect the economy to continue to grow driven by a hardworking labor force, Snow College, favorable broadband access, and proximity to the Greater Salt Lake economic region.

#### Key Findings

- Historical population context Between 2010 and 2020, Sanpete County grew by 615 residents. Driven by natural increase, this resulted in a 2020 Census population of 28,437, the 13<sup>th</sup> largest in Utah.
- Regional context Sanpete County shares an economic link with Piute, Millard, Sevier and Wayne counties. This five-county economic region functions largely as a single consumer market and labor market.





- **Population growth** Sanpete County's population is projected to grow from 28,560 on July 1, 2020 to 40,096 in 2060. Sanpete County's overall population is projected to remain at 13<sup>th</sup> largest from 2020 to 2060.
- Components of change Natural increase is projected to be the primary driver of population growth in Sanpete County throughout the projections period.
- Age composition Sanpete County's population ages over the projection horizon. The share of the total population age 65 and older is projected to increase from 14.5% in 2020 to 16.0% in 2060. The share of the population under 18 is projected to decline, from 28.1% in 2020 to 25.1% in 2060. The median age is projected to rise from 27.2 in 2020 to 29.3 in 2060.
- Economic growth Sanpete County's employment is projected to increase from 13,280 in 2020 to 17,392 in 2060. Leading growth sectors include professional, technical and scientific services, local government, and construction, contributing 41% of employment growth.

### Assumptions

- Fertility The estimated 2020 Total Fertility Rate (TFR) for Sanpete County is 2.11. The TFRs in all regions are predicted to decline, resulting in a TFR of 1.89 in Sanpete County in 2060. Statewide, the TFR is projected to decline from 1.99 in 2020 to 1.78 in 2060.
- Life expectancy The estimated 2020 life expectancy for Sanpete County males is 75.9 and 80.3 for females. Based on historical trends, we project it to rise to 81.7 for males and 85.5 for females by 2060.
- Resource constraints and policy choices These projections for Sanpete County assume no land (including slopes, flood plains, and soils), water, or other resource constraints. Policy choices such as land use, community preferences, and opportunity zones are considered as part of the local review process.
