Utah Long-Term Planning Projection Summary

Washington County



Washington County is the fifth largest in Utah, with a 2020 Census population of 180,279. Between 2010 and 2020, Washington County grew by 42,164 residents, primarily driven by net migration.

Washington County's population is projected to grow from 182,111 on July 1, 2020 to more than 464,000 in 2060. The median age is projected to rise from 37.5 in 2020 to 51.9 in 2060. Additional details on age groups are included below.

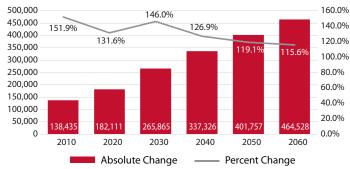
Washington County's economy will continue to grow as county leaders usher in a broader mix of industries driven by attractive economic assets, new tech- and innovation-focused real estate, Utah Tech University, Dixie Technical College, red rock tourism attractions, favorable transportation access, and a growing workforce.

Key Findings

- Historical population context Between 2010 and 2020, Washington County grew by 42,164 residents. Driven by net migration, this resulted in a 2020 Census population of 180,279, the fifth largest county population in Utah.
- Regional context Washington County is the largest population and employment center in Southwest Utah. The Southwest Region was the second fastest growing region, after the Greater Salt Lake Region. The Southwest Region has the smallest percentage of employees who commute from county to county for work.
- **Population growth** Washington County's population is projected to grow from 182,111 on July 1, 2020 to 464,528 in 2060. Washington County's overall population ranking is projected to grow from the fifth largest county in 2020 to fourth largest by 2060.
- Age composition Washington County's population ages over the projection horizon. The share of the total population age 65 and older is projected to increase from 22.3% in 2020 to 33.9% in 2060. The share of the population under 18 is projected to decline, from 26.3% in 2020 to 15.4% in 2060. The median age is projected to rise from 37.5 in 2020 to 51.9 in 2060.

- Components of change Net migration is the primary driver of growth in Washington County, compensating for natural decrease in the latter half of the projection period (more deaths than births).
- Employment growth and Industry composition Washington County's employment is projected to increase from 104,797 in 2020 to 214,794 in 2060. Projected growth sectors include accommodation and food services, retail, construction, and health care and social assistance. Combined these sectors are responsible for a projected 53% of total employment growth.

Major Events/Projects

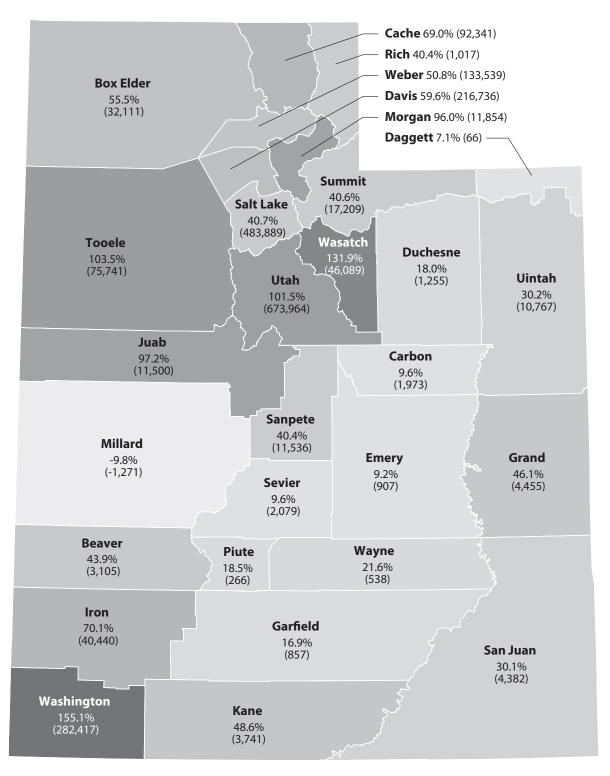
- Economic development plans/CEDS The
 Comprehensive Economic Development Strategy
 sponsored by the U.S. Economic Development
 Administration calls for the prioritization of economic
 diversity, workforce development, infrastructure
 investments (including tourism), and support for
 entrepreneurship. Over the next five to 10 years the CEDS
 also calls for Washington County to emerge as an
 innovation hub that attracts highly skilled and technical
 workers in the 30-50-year age range.
- Lake Powell Pipeline A new 140-mile pipeline to draw water from the Colorado River will deliver more than 83,000 acre feet of water per year to St. George, Washington, Hurricane, Santa Clara, Ivins, La Verkin, Toquerville, Leeds, Virgin, and Apple Valley. These population projections are not constrained by water supply.
- **Tech-Ridge** located on a bluff above downtown St. George, Tech Ridge will host more than 1 million square feet of office space, 60 acres of park and trails, 2,400 residential units, and other mixed uses like restaurants. Tech Ridge is designed to attract technology companies, with access to Utah Tech University, Atwood Innovation Plaza, and Dixie Technical College.
- Atwood Innovation Plaza The Atwood Innovation Plaza includes a Business Resource Center, a co-working center, the Innovation Guidance and Solutions Center, a makerspace, a business incubator, a startup lounge, and educational programs. These resources are available to entrepreneurs and students from Utah Tech University.
- St. George Regional Airport The airport opened in 2011 after the previous airport was too land-constrained for expansion. The new airport includes commercial service by SkyWest, American Airlines, Delta Air Lines, and United Airlines. The surrounding real estate includes hundreds of acres of developable land in St. George City.

Assumptions

- Fertility The estimated 2020 Total Fertility Rate (TFR) for Washington County is 2.05. The TFRs in all regions are predicted to decline, resulting in a TFR of 1.83 in Washington County in 2060. Statewide, the TFR is projected to decline from 1.99 in 2020 to 1.78 in 2060.
- Life expectancy The estimated 2020 life expectancy for Washington County males is 79.7 and 84.0 for females.

 Based on historical trends, we project it to rise to 85.8 for males and 89.5 for females by 2060.
- Resource constraints and policy choices These projections for Washington County assume no land (including slopes, flood plains, and soils), water, or other resource constraints. Policy choices such as land use, community preferences, and opportunity zones are considered as part of the local review process.
